6 For an Act entitled: "An Act relating to the monetary allowance
7 for guests of the Alaska Pioneers' Home;
8 amending Sec. 51-2-13, ACLA 1949, as last
9 amended by Ch. 118, SLA 1957; and providing
10 for an effective date."

11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

12 Section 1. Sec. 51-2-13, ACLA 1949, as last amended by Ch.
13 118, SLA 1957, is amended to read:

14 Sec. 51-2-13. PERSONS ENTITLED TO BE ADMITTED TO HOME.
15 Every worthy person residing in Alaska, and who shall have
16 been a resident of Alaska [THE TERRITORY] continuously for
17 more than five years immediately preceding his application
18 for admission, and who shall be destitute and in need of the
19 aid or benefit of said Home in consequence of physical dis-
20 ability or other cause, shall be entitled to admission
21 thereto subject to the conditions, limitations and penalties
22 prescribed by the rules and regulations of the superintend-
23 ent [BOARD]. But no person shall be admitted as an inmate
24 to the Alaska Pioneers' Home under the provisions of this
25 Act, where the support and maintenance of such person is im-
26 posed by law upon any relative or member of the family of
27 such person.

28 Every person heretofore or hereafter admitted to the
29 Pioneers' Home, except persons admitted under Section 51-2-14,

ACLA 1949, who receives income from any source whatsoever in excess of \$30.00 [FIFTEEN (\$15.00) DOLLARS] per month may be required [BY THE BOARD OF TRUSTEES] to pay such excess to the Superintendent of said Home immediately upon receipt thereof in payment, or part payment, of the cost of his maintenance.

At the end of each month said Superintendent shall transmit all such payments to the State [TERRITORIAL] Treasurer together with the names of the persons making same and the amount paid by each. Provided, that the Superintendent [BOARD OF TRUSTEES] is hereby directed [AUTHORIZED] to pay the sum of \$30.00 [TEN (\$10.00) DOLLARS] per month to any resident without funds.

All moneys thus received shall be covered into the General Fund.

Sec. 2. This Act takes effect on the day after its passage and approval or on the day it becomes law without such approval.
