5 A BILL

6 For an Act entitled: "An Act transferring between certain line
7 item appropriations made for the fiscal
8 year ending June 30, 1961; and providing
9 an effective date."

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

11 Section 1. The sum of \$3,000 is transferred from the line
12 item appropriation for personal services, Division of Civil
13 Defense, Department of Public Safety, for the fiscal year ending
14 June 30, 1961, to the following line item appropriations:

15 (1) To Travel, Civil Defense \$ 1,000

16 (2) To Commodities, Civil Defense \$ 2,000

17 Sec. 2. The sum of \$2,000 is transferred from the line item
18 appropriation made for personal services, Division of Fire
19 Prevention, Department of Public Safety, for the fiscal year ending
20 June 30, 1961, to the line item appropriation for contractual
21 services, Division of State Police, Department of Public Safety.

22 Sec. 3. The sum of \$3,000 is transferred from the line item
23 appropriation made for personal services, Division of State Police,
24 Department of Public Safety, for the fiscal year ending June 30,
25 1961, to the line item appropriation for contractual services,
26 Division of State Police.

27 Sec. 4. The sum of \$17,500 is transferred from the line item
28 appropriation for care of prisoners made to the Division of Youth
29 and Adult Authority, Department of Health and Welfare, for the

1 fiscal year ending June 30, 1961, to be used by that division for
2 the repair and improvement of state jail facilities during the
3 fiscal year ending June 30, 1961.

4 Sec. 5. The following line item transfers are made among the
5 appropriations made to the Commercial Fisheries Division, Depart-
6 ment of Fish and Game for the fiscal year ending June 30, 1961:

- 7 (1) From contractual services to personal services: \$14,700
- 8 (2) From contractual services to equipment: \$ 200
- 9 (3) From travel to equipment: \$ 3,350
- 10 (4) From commodities to equipment: \$ 5,850
- 11 (5) From commodities to meet supplemental expenses
12 of the Alaska Advisors to the American Section
13 of the International North Pacific Fisheries
14 Commission: \$ 2,100

15 Sec. 6. The following line item transfers are made among
16 the appropriations made to the Protection Division, Department
17 of Fish and Game for the fiscal year ending June 30, 1961:

- 18 (1) From personal services to land and structures: \$ 3,000
- 19 (2) From personal services to contractual services: \$29,000
- 20 (3) From personal services to equipment: \$23,000
- 21 (4) From travel to commodities: \$45,000

22 Sec. 7. This Act takes effect on the day after its passage
23 and approval or on the day it becomes law without such approval.
