BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

Section 1. The sum of \$498.42 is appropriated from the  
general fund to reimburse the International Business Machine  
11 Corporation for expenses incurred by the state through the  
12 Department of Administration for freight and supplies during the  
13 fiscal years ending June 30, 1960 and June 30, 1961.

Sec. 2. The Sum of \$33.60 is appropriated from the general  
fund to reimburse the International Business Machine Corporation  
for expenses incurred by the state through the Department of Law  
17 for typewriter repairs during the fiscal year ending June 30,  
18 1960.

Sec. 3. The sum of \$56.56 is appropriated from the general  
fund to reimburse the Juneau-Douglas Telephone Company for expen-  
21 ses incurred by the state through the Department of Revenue for  
22 telephone service during the biennium ending June 30, 1959.

Sec. 4. The sum of \$177.54 is appropriated from the general  
fund to reimburse the Fosse Plumbing Heating Sheet Metal Con-  
25 tractors for expenses incurred by the state through the Depart-  
26 ment of Health and Welfare for the Kake Health Center during the  
27 fiscal year ending June 30, 1960.

Sec. 5. The sum of \$421.95 is appropriated from the general  
fund to reimburse the Pacific Northern Airlines for expenses

2 for transportation furnished during the biennium ending June 30,  
3 1957.

4 Sec. 6. The sum of \$21.55 is appropriated from the general  
5 fund to reimburse the Alaska Railroad for expenses incurred by  
6 the state through the Department of Natural Resources, Division  
7 of Lands for transportation charges during the fiscal year ending  
8 June 30, 1960.

9 Sec. 7. The sum of \$76.50 is appropriated from the general  
10 fund to reimburse the City of Seward for expenses incurred by  
11 the state through the Department of Public Safety for prisoner  
12 care during the fiscal year ending June 30, 1961.

13 Sec. 8. The sum of \$475.00 is appropriated from the general  
14 fund to reimburse the Frontier Flying Service for expenses in-  
15 curred by the state through the Department of Public Safety for  
16 transportation of persomel during the fiscal year ending June  
17 30, 1960.

18 Sec. 9. The sum of \$250.00 is appropriated from the general  
19 fund to reimburse the Wien Alaska Airlines for expenses incurred  
20 by the state through the Department of Public Safety for search  
21 and rescue during the fiscal year ending June 30, 1961.

22 Sec. 10. The sum of \$116.67 is appropriated from the general  
23 fund to reimburse the Del-Air Flying Service for expenses incurred  
24 by the state through the Department of Public Safety for search  
25 and rescue during the fiscal year ending June 30, 1961.

26 Sec. 11. The sum of \$823.38 is appropriated from the general  
27 fund to the Ellis Air Lines for expenses incurred by the state  
28 through the Department of Public Works, Division of Water and  
29 Harbor Facilities for repair of the Craig float during the fiscal

1 year ending June 30, 1961.

2       Sec. 12. The sum of \$300.00 is appropriated from the general  
3 fund to The Trading Union, Inc., for expenses incurred by the  
4 state through the Magistrates Courts for office rental during the  
5 fiscal year ending June 30, 1960.

6       Sec. 13. The sum of \$2,052.65 is appropriated from the  
7 general fund to the General Services Administration for expenses  
8 incurred by the state through the Magistrates Courts for remodel-  
9 ing of rooms during the fiscal year ending June 30, 1960.

10       Sec. 14. The sum of \$857.04 is appropriated from the  
11 general fund to the Alaska Airlines, Inc. for expenses incurred  
12 by the state through the Department of Law for transportation of  
13 witnesses during the fiscal year ending June 30, 1960.

14       Sec. 15. This Act takes effect on the day after its passage  
15 and approval or on the day it becomes law without such approval.
