IN THE LEGISLATURE OF THE STATE OF ALASKA

SECOND LEGISLATURE - FIRST SESSION

A BILL

For an Act entitled: "An Act relating to employment security benefit amounts, amending Subsec. (b) of Sec. 712, Art. VII, Ch. 5, ESLA 1955 as amended by Ch. 169, SLA 1957; and providing for an effective date."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

Section 1. Subsec. (b) of Sec. 712 of Art. VII, Ch. 5, ESLA 1955 as amended by Ch. 169, SLA 1957 is hereby amended to read as follows:

(b) WEEKLY BENEFIT AMOUNT. Except as provided in subsection (a), above, an individual's weekly benefit amount shall be the amount shown in the table below, in the applicable column opposite the amount of his total base period wages as shown in column A. Each individual who establishes a benefit year [ON OR AFTER MAY 1, 1957] shall be entitled to an augmented weekly benefit amount, as shown in the table below, if on the date he establishes his benefit year he has dependents who are in the state [TERRITORY]. The number of dependents shall be determined as of the date he establishes his benefit year, and shall be fixed for the duration of such benefit year. [EACH INDIVIDUAL WHO HAS AN UNEXPIRED BENEFIT YEAR ON APRIL 30, 1957 SHALL BE ENTITLED TO AN AUGMENTED WEEKLY BENEFIT AMOUNT AS DETERMINED BY THE NUMBER OF HIS DEPENDENTS WHO ARE IN THE TERRITORY AS OF APRIL 30, 1957 AND

1 SUCH AUGMENTED WEEKLY BENEFIT AMOUNT SHALL REMAIN FIXED FOR  
 2 THE BALANCE OF HIS BENEFIT YEAR.]
