For an Act entitled: "An Act making certain appropriations, and  
7 providing for an effective date."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

Section 1. The sum of \$200.00 is appropriated from the  
general fund to reimburse Derek Crowell, employee of the Depart-  
11 ment of Fish and Game for personal gear lost in line of duty in  
12 a fire at Old Andraefski State Camp on August 10, 1962.

Section 2. The sum of \$469.50 is appropriated from the  
general fund to reimburse two full time employees and the widow  
of a full time employee of the Department of Fish and Game for  
actual losses in line of duty as a result of a United States Navy  
aircraft crash in October 1961, and a Department of Fish and Game  
aircraft crash in November 1962; said monies to be disbursed on  
properly drawn vouchers for the following persons and in the  
following amounts:

Section 3. The sum of \$12.60 is appropriated from the

Section 4. The sum of \$30.00 is appropriated from the  
general fund to reimburse the Rabbit Creek Garage for towing

3 Section 5. The sum of \$123.25 is appropriated from the  
4 general fund to reimburse the Firestone Tire and Rubber Co. for  
5 tires furnished the Department of Public Safety during the fiscal  
6 year ending June 30, 1959.

7 Section 6. The sum of \$18.60 is appropriated from the  
8 general fund to reimburse the International Business Machines  
9 Corporation for typewriter repair services furnished the State  
10 Superior Court in Fairbanks during the fiscal year ending June 30,  
11 1960.

12 Section 7. This Act takes effect on the day after its  
13 passage and approval or on the day it becomes law without such  
14 approval.
