6 For an Act entitled: "An Act relating to the monetary allowance  
7 for guests of the Alaska Pioneers' Home;  
8 and providing for an effective date."

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

10 \* Section 1. AS 47.25.020 is amended to read:

11 Sec. 47.25.020. ADMISSION TO HOME. (a) Every worthy  
12 person residing in the state who has been a resident of the  
13 state continuously for more than 15 years immediately pre-  
14 ceding his application for admission, and who is destitute  
15 and in need of the aid or benefit of the home because of phys-  
16 ical disability or other cause, is entitled to admission to  
17 the home under the conditions, limitations and penalties  
18 prescribed by the regulations of the office of the governor.  
19 No person may be admitted as a guest to the Alaska Pioneers'  
20 Home under the provisions of Secs. 10 - 110 of this chapter,  
21 if the support and maintenance of the person is imposed by  
22 law upon a relative or member of the family of the person.

23 (b) Every person admitted to the Pioneers' Home, except  
24 a person admitted under Sec. 30 of this chapter, who receives  
25 income from any source in excess of \$30 [\$15] a month may be  
26 required by the office of the governor to pay the excess to  
27 the office of the governor immediately upon receipt of the  
28 money in payment, or part payment, of the cost of his mainten-  
29 ance.

(c) At the end of each month the payments made under (b) of this section shall be transmitted to the commissioner of revenue together with the names of the persons making them and the amount paid by each. The office of the governor may pay the sum of \$30 ~~10~~ a month to a resident without funds.

(d) The money received by the commissioner of revenue shall be deposited in the general fund.

\* Sec. 2. This Act takes effect on the day after its passage and approval or on the day it becomes law without such approval.
