8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

9 \* Section 1. AS 47.25.430(b) is amended to read:

10 (b) No payment under secs. 430 - 610 of this chapter  
11 may be made to an individual who is a resident of a [THE  
12 ALASKA PIONEERS' HOME OR ANOTHER] public institution (ex-  
13 cept as a patient in a public medical institution) or an  
14 individual who is (1) a patient in a public or private in-  
15 stitution for tuberculosis or mental diseases, or (2) diag-  
16 nosed as having tuberculosis or psychosis and is a patient  
17 in a medical institution as a result of the diagnosis.

19 (c) A resident of an [THE ALASKA PIONEERS' HOME OR  
20 OTHER] institution may, at any time he wishes to leave the  
21 institution, apply for assistance under secs. 430 - 610 of

23 vided in the [HOME OR] institution.

29 as a patient in a public medical institution [,] ) or an

1 individual who is a patient in a public or private institu-  
2 tion for tuberculosis or mental diseases, [;] or has been  
3 diagnosed as having tuberculosis or psychosis and is a  
4 patient in a medical institution as a result of the diag-  
5 noses. An inmate of the [ALASKA PIONEERS' HOME OR OTHER]  
6 institution may, at any time he wishes to leave the institu-  
7 tion, apply for assistance under secs. 620 - 780 of this  
8 chapter instead of the support and maintenance provided in  
9 the [HOME OR] institution.
