A BILL

For an Act entitled: "An Act providing for salary increases for employees of the State of Alaska; and providing for an effective date."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

\*Section 1. AS 39.27.010 is amended to read as follows:

Sec. 39.27.010 Monthly salary schedules. The following monthly salary schedules are approved under AS 39.25.150(2) and 24, Ch. 144, SLA 1960, as the pay plan for employees of the State of Alaska:
