6 For an Act entitled: "An Act relating to weight fees for common  
7 carriers, contract carriers and private  
8 carriers; and providing for an effective  
9 date."

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

11 \* Section 1. AS 42.10.240(a) is amended to read:

12 (a) In addition to all other fees to be paid by him,  
13 every common carrier and [,] contract carrier, [AND PRIVATE  
14 CARRIER,] including those operating vehicles not otherwise  
15 registered or licensed by the state, shall pay each year for  
16 each motor vehicle, including a wrecker, tow car, hearse,  
17 ambulance, truck or truck tractor owned or operated by him  
18 on the public highways of the state, based upon the actual  
19 maximum gross unladen weight as set by the carrier in his  
20 application for his regular license plates, or in the case  
21 of vehicles not otherwise licensed, as established by the  
22 manufacturer's advertised weight, the following fees:

23	<u>4,001 pounds but not over</u> [LESS THAN]	
24	12,000 pounds	\$25
25	<u>12,001</u> [12,000] pounds <u>but not over</u> [AND	
26	OVER, BUT LESS THAN] 18,000 pounds	40
27	<u>18,001</u> [OVER 18,000] pounds <u>and over</u>	50

28 \* Sec. 2. AS 42.15 is amended by adding a new section to read:  
29 Sec. 42.15.055. WEIGHT FEES. (a) Every common carrier

1 by bus shall pay each year for each motor bus owned or  
2 operated by him, on the public highways of the state, based  
3 upon the maximum gross unladen weight as set by the carrier  
4 in his application for his regular license plates, the  
5 following fees:

6	4,001 pounds but not over 12,000 pounds	\$25
7	12,001 pounds but not over 18,000 pounds	40
8	18,001 pounds and over	50

9 Provided, however, that the weight fee for a motor bus with  
10 a seating capacity exceeding 20 used exclusively to transport  
11 tourists shall be 50% of that listed in the fee schedule.

12 (b) Buses used exclusively for transportation of  
13 children to and from school shall be exempt from weight fees  
14 designated in this section.

15 \* Sec. 3. This Act takes effect on February 15, 1966.
