5 A BILL

6 For an Act entitled: "An Act creating an Alaska-Pacific Basin  
7 Trade Commission; and providing for an  
8 effective date."

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

10 \* Section 1. PURPOSE. (a) Human beings are likely to con-  
11 tinue to exist on the earth only if the people of the world can  
12 learn to amicably settle international disputes. Throughout the  
13 history of the world, battles for markets have been a major cause  
14 of war; but, as former President Eisenhower has said, "There is  
15 no alternative to peace." The alternative to learning how to  
16 trade peaceably with our neighbors is the unacceptable alternative  
17 of annihilation. Alaska, as a people and as a sovereign state,  
18 has a moral obligation to contribute as much as it can contribute  
19 to international understanding and to overcoming parochial, legal,  
20 and traditional trade barriers with its neighbors.

21 (b) Furthermore, the economic future of Alaska depends  
22 upon developing its international trade. Alaska's economic futur  
23 is based upon its natural resources. The distances and costs of  
24 transportation in commerce with the other states makes it impera-  
25 tive that Alaska develop trade in other areas of the world as well  
26 as stimulate trade with the other states, if early and substantia  
27 growth is to be attained. Alaska's geographical location gives  
28 it the possibility of becoming a leader in international trade  
29 with the countries bordering on the Pacific Ocean. Further,

1 these countries comprise the only existing potential market for  
2 the raw materials of the state, and, with the low cost of water  
3 transportation, the import of certain finished products from  
4 those countries can create a balance of trade. For the purpose  
5 of helping to preserve the peace as well as of stimulating and  
6 expanding trade with the Pacific Basin countries it is necessary  
7 that a commission be created.

8 \* Sec. 2. AS 44.19 is amended by adding new sections to read:

9 ARTICLE 7. ALASKA-PACIFIC BASIN TRADE COMMISSION.

10 Sec. 44.19.700. ALASKA-PACIFIC BASIN TRADE COMMISSION.

11 There is created an Alaska-Pacific Basin Trade Commission in  
12 the Office of the Governor.

13 Sec. 44.19.710. COMPOSITION AND TERMS OF OFFICE. (a)

14 The commission consists of 15 members who, unless otherwise  
15 provided for in (b) of this section, are appointed by the  
16 governor for overlapping three-year terms.

17 (b) The governor shall appoint the president of the  
18 senate, the speaker of the house of representatives, and the  
19 members of the Alaska delegation in Congress as ex officio  
20 members of the commission. The remaining members of the  
21 commission shall be appointed because of their knowledge  
22 and experience concerning commerce, labor, management, mining,  
23 fishing, timber, tourism, banking, transportation, education  
24 or other appropriate vocations, can be expected to contri-  
25 bute significantly to the achievement of the purposes for  
26 which the commission is created.

27 Sec. 44.19.720. ORGANIZATION AND MEETING OF THE  
28 COMMISSION. Within 30 days after the appointment of all  
29 members, the commission shall meet at a time and place

1 agreed upon by a majority of the members through corres-  
2 pondence to elect from the membership a chairman, a  
3 vice chairman and such other officers as they consider  
4 necessary, and to establish policy and rules to govern  
5 the commission. Eight members constitute a quorum to  
6 do business.

7 Sec. 44.19.730. COMPENSATION, PER DIEM, AND EXPENSES.  
8 Members of the commission are not entitled to a salary  
9 but employees and commissioners are entitled to trans-  
10 portation allowances and per diem provided for in AS 39.20.

11 Sec. 44.19.740. EXECUTIVE DIRECTOR. (a) The commis-  
12 sion shall employ an executive director. The executive  
13 director shall be professionally trained and experienced in  
14 the performance of his duties. The selection of the execu-  
15 tive director is subject to the approval of the governor.  
16 The commission may delegate to the executive director the  
17 functions it considers proper.

18 (b) The executive director shall not have any  
19 business interests that may be affected, either favorably  
20 or unfavorably, by the operation of the commission.

21 Sec. 44.19.750. DUTIES. The primary duty of the  
22 commission is to formulate specific projects for developing  
23 each of the potentially marketable resources in the state,  
24 and then to find persons in the Pacific Basin countries to  
25 develop and purchase the resources. In the interest of  
26 maintaining a balance between imports and exports, the  
27 commission also has the duty of assisting entrepreneurs in  
28 the Pacific Basin countries to find markets for their  
29 products in Alaska. The commission, in accomplishing its

1 duties, shall

2 (1) invite citizens of foreign countries to visit  
3 Alaska informally to become acquainted with the state, meet  
4 its businessmen, labor leaders, and government officials,  
5 for the purpose of increasing mutual understanding on a  
6 personal basis between citizens of foreign countries and  
7 Alaskans;

8 (2) arrange for and hold international conferences  
9 in Alaska to discuss specific development or trade projects,  
10 to acquaint citizens of countries of the Pacific Basin with  
11 development and trade prospects in Alaska.

12 Sec. 44.19.760. POWERS. The commission may elect sub-  
13 committees of any number of members to collect information  
14 and to travel to the countries of the Pacific Basin to carry  
15 out its duties.

16 Sec. 44.19.770. DEFINITIONS. In secs. 700-780 of  
17 this chapter "commission" means the Alaska-Pacific Basin  
18 Trade Commission. The commission may make reports to the  
19 legislature and may recommend legislation relating to  
20 projects to develop international trade.

21 Sec. 44.19.780. SHORT TITLE. Secs. 700-780 of this  
22 chapter may be cited as the Alaska-Pacific Basin Trade  
23 Commission Act.

24 \* Sec. 3. INITIAL APPOINTMENTS. Of the commission members  
25 appointed at large under AS 44.19.710(b), the governor shall  
26 appoint three for an initial term of one year, three for an  
27 initial term of two years, and four for an initial term of three  
28 years.

29 \* Sec. 4. EFFECTIVE DATE. This Act takes effect on the day  
CSHB 207 am

1 after its passage and approval or on the day it becomes law  
2 without such approval.
