5 A BILL

6 For an Act entitled: "An Act restricting certain state-owned
7 lands and waters to use as a public recrea-
8 tion area."

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

10 * Section 1. PURPOSE. The purpose of this Act is to restrict
11 state-owned lands and waters within the boundaries described in
12 this Act to use as a public recreation area. Under the provisions
13 of AS 38.05.300, state land, water, or land and water containing
14 more than 640 acres may be closed to multiple purpose use only by
15 Act of the legislature. Inasmuch as the area described in this Act
16 exceeds 640 acres, this Act is intended to except the area described
17 from the provisions of AS 38.05.300.

18 * Sec. 2. DESIGNATED STATE LANDS AND WATERS RESTRICTED TO USE
19 AS PUBLIC RECREATION AREA. The presently state-owned lands and
20 waters and all those acquired in the future by the state, lying
21 within the following described boundary, are hereby designated as
22 the Nancy Lake State Recreation Area, are reserved from all uses
23 incompatible with their primary function as public recreation
24 lands, and are assigned to the Department of Natural Resources for
25 control, development, and maintenance:

26 Beginning at the SE corner of Section 36, T19N,R5W,S.M.,
27 thence northerly along the section line to its intersection
28 with the meander line of an unnamed lake, thence northeasterly
29 along the meanders of the unnamed lake to the intersection of

1 the south 1/16 line of Section 36, T19N,R5W,S.M., thence
2 westerly along the said south 1/16 line to C-S 1/16 corner,
3 thence southerly along the 1/4 line to the S 1/4 corner,
4 thence westerly along the section line to the intersection
5 of the meander line of an unnamed lake, thence northerly,
6 westerly, and southerly along the meander of said lake to the
7 point of intersection of the south section line of said Sec-
8 tion 36, thence westerly to the SW corner of Section 36,
9 thence northerly along the west section line of said Section
10 36 to the S-S 1/64 corner which is common to the SW corner of
11 Lot 18, said Section 36, thence easterly along the lot line to
12 its intersection with the meander line of the lake, thence
13 easterly and northerly along the meander lines of the lake to
14 the intersection of the north line of Lot 17, said Section 36,
15 thence westerly along the lot line to the NWC corner of Lot
16 17 which is common to the E 1/4 corner of Section 35, T19N,
17 R5W,S.M., thence westerly along the centerline of said Section
18 35 to the W 1/4 corner of said Section 35, thence southerly
19 along the west section line to the SW corner of Section 35
20 all within T19N,R5W,S.M., thence southerly along the west
21 section lines of Sections 2 and 11, T18N,R5W,S.M. to the SW
22 corner of said Section 11, thence westerly along the north
23 section line of Section 15 to the NW corner of Section 15,
24 Thence southerly along the west section line of Section 15, to
25 the SW corner of Section 15, thence westerly along the north
26 section line of Section 21 to the NW corner of Section 21,
27 thence southerly along the west section line of Section 21 to
28 the SW corner of Section 21, thence easterly along the south
29 section line of Section 21 to the intersection of the meander

1 line of Red Shirt Lake, thence southerly easterly and north-
2 erly along the meander lines of said lake to the intersection
3 of the east-west centerline of Section 27, thence easterly
4 along the centerline of Section 27 to the C-E 1/16 corner of
5 Section 27, thence southerly along the east 1/16 line of
6 Section 27 to the S-E 1/16 corner of Section 27, thence
7 easterly along south 1/16 line of Section 27 to the S 1/16
8 corner common to Sections 26 and 27, thence southerly along
9 the section line of Section 26 and Section 35 to the SW
10 corner of Section 35, thence easterly along the south section
11 line to the intersection of the meander line of Butterfly
12 Lake (locally known as Delyndia Lake) all lying within T18N,
13 R5W, S.M., thence southerly and easterly along the meander
14 lines of said lake to the intersection with the east-west
15 centerline of Section 6, T17N,R4W,S.M., thence easterly along
16 the east-west centerline of said Section 6 to the E 1/4
17 corner of Section 6, thence southerly along the east section
18 line of said Section 6 to the SW corner of Section 5, thence
19 easterly along the section line of said Section 5 to the SE
20 corner of Section 5, thence northerly along the section line
21 to the NE corner of Section 5 all in T17N,R4W, S.M., thence
22 northerly along the east section line of Sections 32, 29, 20,
23 17, 8 and 5, T18N,R4W,S.M. to the E 1/4 corner of Section 4,
24 thence easterly along the east-west centerline of said
25 Section 4 to the C-W 1/16 corner of Section 4, thence north-
26 erly along the west 1/16 line to the SE corner of Lot 4,
27 Section 4, T18N,R4W,S.M., thence westerly along lot line of
28 said Lot 4 to the SW corner of said Lot 4, thence northerly
29 along the lot line of said Lot 4 to the NW corner of said

1 Lot 4, thence easterly along the lot line of said Lot 4 to
2 the intersection of the lot line with the meander line of
3 Nancy Lake, thence southerly, easterly, northerly and westerly
4 along the meander lines of said lake in a generally counter-
5 clockwise direction to the intersection of the east-west
6 centerline of Section 32, T19N,R4W,S.M., thence westerly
7 along the east-west centerline of said Section 32 to the W
8 1/4 corner of said Section 32, thence south along the section
9 line to the SW corner of Section 32, thence west along the
10 south section line of Section 31, T19N,R4W,S.M. to the SW
11 corner of said Section 31, which is common with the SE corner
12 of Section 36, T19N,R5W, S.M., the point of beginning.

13 * Sec. 3. INCOMPATIBLE USES PROHIBITED. The commissioner of
14 natural resources shall designate by regulation incompatible uses
15 within the boundaries of the Nancy Lake State Recreation Area in
16 accordance with the requirements of sec. 1 of this Act, and those
17 incompatible uses designated shall be prohibited or restricted, as
18 provided by regulation.

19 * Sec. 4. PURCHASE AUTHORIZED. The commissioner of natural
20 resources may acquire, by purchase in the name of the state, title
21 to or interest in real property lying within the boundaries of
22 the Nancy Lake State Recreation Area.
