6 For an Act entitled: "An Act making certain appropriations for  
7 claims arising from prior years; and provid-  
8 ing for an effective date."

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

10 \* Section 1. The sum of \$5,506.04 is appropriated from the  
11 general fund to pay Robert E. Sheldon for retired benefits due  
12 under the provisions of Chapter 102, SLA 1951, withheld during  
13 1959 and 1960.

14 \* Sec. 2. The sum of \$26 is appropriated from the general fund  
15 to reimburse the Anchorage Times Publishing Co. for advertising  
16 furnished the Department of Administration in fiscal year 1963-64.

17 \* Sec. 3. The sum of \$453.72 is appropriated from the general  
18 fund for payment to Robert G. Langberg for wages due from Septem-  
19 ber, 1961.

20 \* Sec. 4. The sum of \$15,306 is appropriated from the general  
21 fund to the Matanuska-Susitna Borough to recover the proceeds of  
22 state sales of borough selected lands in the Matanuska-Susitna  
23 Borough during the fiscal year ending June 30, 1964.

24 \* Sec. 5. The sum of \$300 is appropriated from the general  
25 fund to reimburse Mrs. Edgar Tweet for property reclaimed in 1961.

26 \* Sec. 6. The sum of \$768.35 is appropriated from the general  
27 fund to the Department of Revenue for the purchase of stale date  
28 warrants.

29 \* Sec. 7. The sum of \$3,500 is appropriated from the general

1 fund to Al Moseley for damage caused to his aircraft at the  
2 Fairbanks International Airport.

3 \* Sec. 8. The sum of \$8,330 is appropriated from the general  
4 fund to the Department of Education for reimbursement to the  
5 federal government for audit exceptions taken during 1959-1962.

6 \* Sec. 9. The sum of \$350 is appropriated from the general  
7 fund to Alfred J. Opland to rectify an error in a teaching con-  
8 tract for fiscal year 1957-1958.

9 \* Sec. 10. The sum of \$9,700 is appropriated from the general  
10 fund to Dr. Jack W. Clarke in payment for medical services  
11 rendered in 1960-1962 to various persons under AS 23.35.

12 \* Sec. 11. This Act takes effect on the day after its passage  
13 and approval or on the day it becomes law without such approval.
