6 For an Act entitled: "An Act relating to pay increments for
7 State employees assigned to remote
8 locations; and providing for an effective
9 date."

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

11 * Section 1. AS 39.27 is amended by adding new sections to
12 read:

13 Sec. 39.27.020. PAY INCREMENTS IN REMOTE LOCATIONS.

14 The following pay increments are approved under AS 39.25.
15 150(2) as an amendment to the pay plan for employees of
16 the state.

17 (1) Permanent employees assigned to permanent
18 duty stations at locations more than one hundred miles
19 from the Ketchikan, Juneau, Anchorage, or Fairbanks city
20 boundary and which are accessible to one of the above
21 cities by road, railroad, or ferry shall be paid at a
22 rate three percent above the pay provided by sec. .010
23 of this chapter.

24 (2) Permanent employees assigned to permanent
25 duty stations at locations which are not accessible to
26 Ketchikan, Juneau, Anchorage, or Fairbanks by road, railroad,
27 or ferry shall be paid at a rate six percent above the
28 pay provided by sec. .010 of this chapter.

29 (3) The commissioner of administration shall

promulgate regulations designating permanent duty stations which are eligible for pay increments under this section.

Sec. 39.27.030. LEGISLATIVE INTENT. It is the intent of the legislature as funds become available to base the salary scale of state employees in different geographical areas of Alaska on the Cost of Living Index for the Cities of Ketchikan, Juneau, Anchorage and Fairbanks as compiled by the Bureau of Labor Statistics of the U. S. Department of Labor, except that no salaries shall be reduced in establishing or later implementing this plan.

Sec. 39.27.040. State employees in the following districts shall be paid at a rate which is the specified percentage above the pay provided by sec. 010 of this chapter before the remote location increment provided by sec. 020 is added:

- (1) House Election Districts 1 and 2One per cent
- (2) House Election Districts 3,4 and 5 ..Three per cent
- (3) House Election Districts 6 and 11 ...Two and one-half per cent
- (4) House Election Districts 13, 14, 15, 16, 17, 18 and 19 Two per cent
- (5) House Election District 12 Seven per cent

* Sec. 2. This Act takes effect on July 16, 1966.
