2 HOUSE RESOLUTION NO. 22

3 IN THE LEGISLATURE OF THE STATE OF ALASKA

4 FOURTH LEGISLATURE - SECOND SESSION

5 Relating to the issuance and sale  
6 of certain revenue bonds of the  
7 state.

8 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES:

9 WHEREAS Ch. 88, SLA 1961, authorizes the issuance and sale  
10 of revenue bonds of the state for a total principal sum not to  
11 exceed \$7,000,000 to finance the acquisition, equipping, construc-  
12 tion, and installation of improvements to the Anchorage and  
13 Fairbanks International Airports when found to be necessary by  
14 the Commissioner of Public Works; and

15 WHEREAS construction of the new concourse for the Anchorage  
16 International Airport is not proceeding sufficiently to insure  
17 that these new facilities will be completed in time for the  
18 Alaska Centennial celebration; and

19 WHEREAS there is a great need for the new concourse to be  
20 completed in time for the centennial celebration because of the  
21 anticipated influx of a great many visitors to Alaska who will be  
22 obliged to use the facilities of Anchorage International Airport  
23 and also because of the increased amount of air traffic which  
24 will use Anchorage International Airport during the centennial  
25 year and thereafter; and

26 WHEREAS the sale and issuance of \$1,000,000 in revenue  
27 bonds at this time would greatly facilitate and accelerate the  
28 completion of the Anchorage International Airport concourse; and

29 WHEREAS the issuance and sale of revenue bonds of the state

1 for this purpose has been authorized and it is believed there  
2 exists, at the present time, a favorable market for the sale of  
3 \$1,000,000 worth of revenue bonds on a short-term basis;

4 BE IT RESOLVED that the Governor is respectfully requested  
5 to direct the Commissioner of Public Works to immediately  
6 implement the provisions of Ch. 88, SLA 1961; and be it

7 FURTHER RESOLVED that the Governor is respectfully requested  
8 to direct the State Bond Committee to immediately offer revenue  
9 bonds of the state for sale in the total principal sum not to  
10 exceed \$1,000,000 in accordance with the committee's powers and  
11 duties under Ch. 88, SLA 1961 to facilitate and accelerate the  
12 construction of the new concourse at Anchorage International  
13 Airport.
