6 For an Act entitled: "An Act increasing the salaries of the  
7 governor, secretary of state, the heads of  
8 departments, and the judges of the supreme  
9 and superior courts; and providing for an  
10 effective date."

11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

12 \* Section 1. AS 39.20.010 is amended to read:

13 Sec. 39.20.010. ANNUAL SALARY OF GOVERNOR. The annual  
14 salary of the governor is \$27,500 [\$25,000]. The salary  
15 shall be paid in equal monthly installments.

16 \* Sec. 2. AS 39.20.030 is amended to read:

17 Sec. 39.20.030. ANNUAL SALARY OF SECRETARY OF STATE.  
18 The annual salary of the secretary of state is \$21,000  
19 [\$18,000]. The salary shall be paid in equal monthly install-  
20 ments.

21 \* Sec. 3. AS 39.20.080 is repealed and re-enacted to read:

22 Sec. 39.20.080. SALARIES OF DEPARTMENT HEADS. The  
23 head of each principal executive department of the state  
24 upon appointment and qualification is entitled to an annual  
25 salary. The annual salary of each department head is  
26 \$20,000, except that the annual salary of the adjutant  
27 general is \$17,000.

28 \* Sec. 4. AS 22.05.140(a) is amended to read:

29 (a) The chief justice shall receive \$25,500 [\$23,500]

1 annually, and each associate justice shall receive \$24,500  
2 ~~[\$22,500]~~ annually as compensation. The compensation is  
3 payable monthly in 12 equal installments. Compensation of  
4 the chief justice or of an associate justice shall not be  
5 diminished during his term of office, unless by general law  
6 applying to all salaried officers of the state.

7 \* Sec. 5. AS 22.10.190(a) is amended to read:

8 (a) Each superior court judge shall receive \$21,000  
9 ~~[\$19,000]~~ annually, as compensation, payable monthly in 12  
10 equal installments. The compensation of a judge shall not  
11 be diminished during his term of office, unless by general  
12 law applying to all salaried officers of the state.

13 \* Sec. 6. This Act takes effect July 1, 1965.
