6 For an Act entitled: "An Act establishing a certain area of the state as a  
7 state game sanctuary to be known as the McNeil River  
8 State Game Sanctuary and otherwise providing for the  
9 sanctuary."

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

11 \* Section 1. PURPOSE. The legislature intends in this Act to provide  
12 for the permanent protection of brown bear and other wildlife population  
13 and their vital habitat in the area of the McNeil River so that these  
14 resources may be preserved for scientific, esthetic and educational purposes.

15 \* Sec. 2. AS 16.20 is amended by adding new sections to read:

16 Article 4. MCNEIL RIVER STATE GAME SANCTUARY.

17 Sec. 16.20.160. SANCTUARY ESTABLISHED. The following described  
18 area and adjacent state waters are established as a state game sanctuary  
19 to be known as the McNeil River State Game Sanctuary:

20 Beginning at the NE corner of Section 13, T 12 S R 30 W, S. M.,  
21 westerly along the section lines to the NW corner of Section 18,  
22 T 12 S R 30 W, S. M., thence southerly along the township boundary  
23 to the SW corner of T 12 S R 30 W, S. M., thence westerly along the  
24 north boundary of T 13 S R 31 W, S. M., to the NW corner of T 13 S  
25 R 31 W, S. M., thence westerly along the north boundary of T 13 S  
26 R 32 W, S. M., to the NW corner of T 13 S R 32 W, S. M., thence  
27 southerly along the west boundary of T 13 S R 32 W, S. M., to the  
28 SW corner of T 13 S R 32 W, S. M., thence southerly along the west  
29 boundary of T 14 S R 32 W, S. M., to the SW corner of Section 30,

1 T 14 S R 32 W, S. M., thence easterly along the section lines to  
2 the SE corner of Section 27, T 14 S R 32 W, S. M., thence northerly  
3 along the section lines to the NE corner of Section 15, T 14 S  
4 R 32 W, S. M., thence easterly along the section lines to the east  
5 boundary of T 14 S R 32 W, S. M., thence northerly along the east  
6 boundary of T 14 S R 32 W, S. M., to the NE corner of T 14 S R 32 W,  
7 S. M., thence easterly along the south boundary of T 13 S R 31 W,  
8 S. M., to the SE corner of T 13 S R 31 W, S. M., thence northerly  
9 along the west boundary of T 13 S R 31 W, S. M., to the NE corner  
10 of Section 24, T 13 S R 31 W, S. M., thence easterly along the  
11 section lines to the SE corner of Section 16, T 13 S R 30 W, S. M.,  
12 thence northerly along the section lines to the NE corner of Section  
13 4, T 13 S R 30 W, S. M., thence easterly along the south boundary  
14 of T 12 S R 30 W, S. M., to the SE corner of T 12 S R 30 W, S. M.,  
15 thence easterly along the south boundary of T 12 S R 29 W, S. M.,  
16 to the shoreline of Horseshoe Cove located in Section 32, T 12 S  
17 R 29 W, S. M., thence northerly, westerly, and northerly along the  
18 line of mean high tide to the point of beginning.

20 **Sec. 16.20.170. APPLICABILITY OF SECS. 120 - 140 OF THIS CHAPTER.**  
21 The provisions of secs. 120 - 140 of this chapter relating to admin-  
22 istration, multiple use and sale and lease of the Walrus Islands State  
23 Game Sanctuary apply also with respect to the McNeil River State Game  
24 Sanctuary.
