6 For an Act entitled: "An Act relating to centralized occupational and  
7 professional licensing; and providing for an  
8 effective date."

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

10 \* Section 1. AS 08.01.010 is amended by adding a new paragraph to read:

11 (16) Board of Construction Contractors

12 \* Sec. 2. AS 08.01.100 is amended to read:

13 Sec. 08.01.100. LICENSE RENEWAL, LAPSE AND REINSTATEMENT. (a)

14 All licenses shall be renewed biennially on the dates set by the  
15 department with the approval of the respective board.

16 (b) A registration, license, permit or certificate requiring  
17 renewal to continue effective must be renewed on or before the date  
18 set by the department or it will lapse. A penalty of \$10 shall be  
19 charged in addition to all delinquent renewal fees for reinstatement  
20 of a registration, license, permit or certificate which remains  
21 lapsed for more than 60 days.

22 \* Sec. 3. AS 08.04.430 is amended to read:

23 Sec. 08.04.430. EXPIRATION AND RENEWAL. Any permit or regis-  
24 tration under secs. 390 - 420 of this chapter [EXPIRES ON DECEMBER 31  
25 OF EACH YEAR AND], unless revoked or suspended, shall be renewed  
26 biennially [BY THE BOARD ANNUALLY] upon payment of a renewal fee in  
27 the same amount as the initial biennial [ORIGINAL] fee.

29 Sec. 08.12.150. REINSTATEMENT OF LAPSED LICENSE. A lapsed

1 license may be reinstated if it has not remained lapsed for more than  
2 five years.

4 (c) A fee of \$5 for each document shall be charged for certified  
5 copies of an official document on file with the board.

7 Sec. 08.88.241. REINSTATEMENT OF LAPSED LICENSE. A licensee who  
8 was required to take an examination before receiving a license and whose  
9 licens; has lapsed for more than three years may be required to be re-  
10 examined prior to reinstatement.

11 \* Sec. 7. The following laws are repealed: AS 08.12.140; AS 08.28.210;  
12 AS 08.32.080; AS 08.36.290(7); AS 08.68.250(a); and AS 08.72.180.
