6 For an Act entitled: "An Act relating to the definition of carriers under  
7 the Alaska Motor Freight Carrier Act."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

9 \* Section 1. AS 42.10.420 is amended by adding a new paragraph to read:

10 (10) "carrier" means a person who at any time uses, rents,  
11 leases or otherwise provides a motor vehicle to transport persons or  
12 property for compensation.

13 \* Sec. 2. AS 42.10.420(2) is amended to read:

14 (2) "common carrier" includes

15 (A) a carrier [PERSON] who undertakes to transport  
16 property for the general public by motor vehicle for compensation,  
17 over regular or irregular routes, on regular or irregular sched-  
18 ules, including motor vehicle operations of other carriers by rail  
19 or water and of express or forwarding companies;

20 (B) a carrier [PERSON] who leases, rents, or provides  
21 a motor vehicle for the use of another in transporting property,  
22 and who provides, procures, or arranges for, directly or indirectly,  
23 or by course of dealing, a driver or operator for the motor vehicle  
24 or the necessary authority for the use of it on a public highway,  
25 except when the motor vehicle is leased to an authorized common  
26 carrier or contract carrier under rules and regulations to be  
27 prescribed by the commission;

28 (C) a carrier [PERSON] engaged in the business of pro-  
29 viding, contracting for or undertaking to provide transportation

1 of property for compensation over the public highways as a broker  
2 or forwarder;

3 • Sec. 3. AS 42.10.420(3) is amended to read:

4 (3) "contract carrier" includes all carriers [MOTOR VEHICLE  
5 OPERATORS] not included under the term "common carrier" or "private  
6 carrier" and includes any carrier [PERSON] who under special and indi-  
7 vidual contracts or agreements transports property by motor vehicle for  
8 compensation; contract carrier includes a carrier [PERSON] engaged in  
9 the business of providing, contracting for, or undertaking to provide  
10 transportation of property for compensation over the public highways as  
11 broker or forwarder;

12 • Sec. 4. AS 42.10.420(7) is amended to read:

13 (7) "private carrier" is a carrier [PERSON] who, in his own  
14 vehicle, transports only property owned or being bought or sold by him  
15 in good faith when the transportation is an incidental adjunct to some  
16 other established primary private business, other than transportation,  
17 owned or operated by him in good faith, and also includes all carriers  
18 [PERSONS] who rent, lease, or otherwise provide a motor vehicle for use  
19 of others in transporting property, and who, in connection therewith,  
20 do not provide, procure, or arrange for, directly, indirectly, or by  
21 course of dealing, a driver or operator for the motor vehicle;
