5 A BILL

6 For an Act entitled: "An Act increasing the salaries of the governor,  
7 secretary of state, the heads of departments, and the  
8 judges of the supreme, superior and district courts;  
9 and providing for an effective date."

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

11 \* Section 1. AS 39.20.010 is amended to read:

12 Sec. 39.20.010. ANNUAL SALARY OF GOVERNOR. The annual salary  
13 of the governor is \$30,000 [\$27,500]. The salary shall be paid in  
14 equal monthly installments.

15 \* Sec. 2. AS 39.20.030 is amended to read:

16 Sec. 39.20.030. ANNUAL SALARY OF SECRETARY OF STATE. The annual  
17 salary of the secretary of state is \$25,000 [\$21,000]. The salary  
18 shall be paid in equal monthly installments.

19 \* Sec. 3. AS 39.20.080 is amended to read:

20 Sec. 39.20.080. SALARIES OF DEPARTMENT HEADS. The head of each  
21 principal executive department of the state upon appointment and  
22 qualification is entitled to an annual salary. The annual salary of  
23 each department head is \$25,000 [\$20,000].

24 \* Sec. 4. AS 22.05.140(a) is amended to read:

25 (a) The chief justice shall receive \$29,000 [\$25,500] annually,  
26 and each associate justice shall receive \$28,000 [\$24,500] annually  
27 as compensation. The compensation is payable monthly in 12 equal  
28 installments. Compensation of the chief justice or of an associate  
29 justice shall not be diminished during his term of office, unless by

1 general law applying to all salaried officers of the state.

2 \* Sec. 5. AS 22.10.190(a) is amended to read:

3 (a) The presiding judge shall receive \$26,500 annually, and each  
4 other [EACH] superior court judge shall receive \$26,000 [\$21,000]  
5 annually, as compensation, payable monthly in 12 equal installments.  
6 The compensation of a judge shall not be diminished during his term  
7 of office, unless by general law applying to all salaried officers of  
8 the state.

9 \* Sec. 6. AS 22.15.220(a) is amended to read:

10 (a) Each district judge shall receive \$20,000 annual compensation  
11 [TO BE DETERMINED BY THE SUPREME COURT, BUT, IN ANY EVENT, NOT LESS  
12 THAN \$12,000 OR MORE THAN \$16,000]. Compensation shall be payable  
13 [ANNUALLY] in 12 equal monthly installments.

14 \* Sec. 7. This Act takes effect July 1, 1967.
