6 For an Act entitled: "An Act relating to the definition of 'public utility'."

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

8 * Section 1. AS 42.05.640(2) is amended to read:

9 (2) "public utility" or "utility" includes every corporation,
10 whether public, cooperative, or otherwise, company, individual, or
11 association of individuals, their lessees, trustees, or receivers
12 appointed by a court, that owns, operates, manages, or controls any
13 plant, pipeline, [PLAN] or system producing an annual gross income in
14 excess of \$25,000 for the purpose of furnishing any of the following
15 services to the public, for compensation: (A) [FOR] the generation,
16 transmission, or distribution of electric energy and power, (B) [FOR THE
17 FURNISHING OF] telephone or telegraph communications, (C) [FOR] the
18 [TRANSMISSION OR] distribution of heat, natural or manufactured gas,
19 (D) water or oil by pipeline, [OIL OR OTHER PETROLEUM PRODUCTS, OR
20 WATER, OR FOR THE FURNISHING OF] community sewer services, and (E) the
21 plant, pipeline and facilities used for any of the [FOREGOING] purposes
22 in (A) - (D) of this subsection; this chapter does not apply to a
23 person who furnishes water or oil or other petroleum products by
24 tank, wagon, or similar conveyance, nor to a municipally owned and
25 operated utility; this chapter does not apply to a person engaged in the
26 production or gathering of natural gas or oil nor to the facilities
27 used for those purposes; this chapter does not apply to a person
28 engaged in the distribution of natural or manufactured gas or oil to
29 industrial customers only and not to the public generally [PIPELINE,

1 PLANT, SYSTEM, OR EQUIPMENT USED PRIMARILY FOR GATHERING, COLLECTING,
2 TRANSPORTING, OR SHIPPING CRUDE OIL, NATURAL GAS, CONDENSATE OR OTHER
3 PETROLEUM SUBSTANCE OR PRODUCT PRODUCED BY OR BELONGING TO THE OWNER,
4 OPERATOR, OR MANAGER OF THE PIPELINE, PLANT, SYSTEM, OR EQUIPMENT];
