5 A BILL

6 For an Act entitled: "An Act creating a Board of Welding Examiners."

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

8 * Section 1. AS 08 is amended by adding a new chapter to read:

9 CHAPTER 99. BOARD OF WELDING EXAMINERS.

10 Sec. 08.99.010. CREATION AND MEMBERSHIP OF BOARD. There is
11 created a Board of Welding Examiners, consisting of seven members
12 appointed by the governor.

13 Sec. 08.99.020. TERM OF OFFICE. Board members serve a term of
14 five years; provided that of the members first appointed one shall be
15 appointed for a term of one year, one for two years, one for three
16 years, one for four years, and three for terms of five years.

17 Sec. 08.99.030. SOURCE OF APPOINTMENTS. The governor shall
18 appoint board members from a list of persons prepared by the Alaska
19 Chapter of American Welding Society and submitted at least 30 days
20 before the expiration of a term and not more than 60 days after a
21 vacancy occurs in an unexpired term. The list shall contain not less
22 than two recommended candidates for each appointment. The governor
23 shall make appointments within 30 days after receiving the list.

24 Sec. 08.99.040. REMOVAL FROM OFFICE. Each member holds office
25 at the pleasure of the governor notwithstanding the member's term.

26 Sec. 08.99.050. QUALIFICATIONS OF BOARD MEMBERS. Each member of
27 the board shall be a citizen of the United States and a resident of
28 the state.

29 Sec. 08.99.060. MEETINGS. The board shall meet at least once a

1 year.

2 Sec. 08.99.070. QUORUM. A majority of the board constitutes a
3 quorum.

4 Sec. 08.99.080. POWERS AND DUTIES OF THE BOARD. The board shall

5 (1) establish and promulgate rules and regulations concerning
6 certification of welders in the state;

7 (2) establish and define certification tests as they apply
8 to various types and categories of work done in and for the state;

9 (3) work with federal and private agencies and specifying
10 engineers to establish uniform testing and certifying methods for all
11 welders throughout the state;

12 (4) work with federal agencies and the agencies of other
13 states to establish reciprocity agreements;

14 (5) set up criteria and define experience and documentary
15 requirements which may be accepted in lieu of physical certification
16 tests in the state;

17 (6) set the fees for the welder certification tests;

18 (7) examine, certify, and renew the certification of
19 qualified applicants;

20 (8) keep a record of its proceedings, and submit annual
21 reports to the governor and the legislature.

22 Sec. 08.99.090. APPLICABILITY OF ADMINISTRATIVE PROCEDURE ACT.

23 The board shall comply with the Administrative Procedure Act (AS 44.62).

24 Sec. 08.99.100. EXPENSES. Members of the board are entitled to
25 the per diem and travel expenses allowed by law.
