6 For an Act entitled: "An Act relating to compensation of judicial officers,  
7 state officers and employees; and providing for an  
8 effective date."

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

10 \* Section 1. AS 22.05.140(a) is amended to read:

11 (a) The monthly salary of the chief justice is 95 per cent of the  
12 monthly salary of the governor. The monthly salary of each associate  
13 justice is 91 per cent of the monthly salary of the governor [THE CHIEF  
14 JUSTICE SHALL RECEIVE \$27,000 ANNUALLY, AND EACH ASSOCIATE JUSTICE  
15 SHALL RECEIVE \$26,000 ANNUALLY AS COMPENSATION. THE COMPENSATION IS  
16 PAYABLE MONTHLY IN 12 EQUAL INSTALLMENTS]. Compensation of the chief  
17 justice or of an associate justice shall not be diminished during his  
18 term of office, unless by general law applying to all salaried officers  
19 of the state.

21 (a) The monthly salary of each superior court judge is 83 per cent  
22 of the monthly salary of the governor [EACH SUPERIOR COURT JUDGE SHALL

24 INSTALLMENTS]. The compensation of a judge shall not be diminished  
25 during his term of office, unless by general law applying to all salaried  
26 officers of the state.

17           Sec. 39.27.020. PAY INCREMENTS IN REMOTE LOCATIONS. The  
18 following pay increments are approved under AS 39.25.150(2) as an  
19 amendment to the pay plan for employees of the state.

20           (1) Permanent employees assigned to permanent duty stations  
21 at locations more than 100 miles from the Ketchikan, Juneau, Anchorage,  
22 or Fairbanks city boundary and which are accessible to one of the  
23 above cities by road, railroad, or ferry shall be paid at a rate  
24 in the appropriate salary schedule one step higher than [THREE PER CENT  
25 ABOVE] the pay provided by sec. 10 of this chapter.

26           (2) Permanent employees assigned to permanent duty stations  
27 at locations which are not accessible to Ketchikan, Juneau, Anchorage,  
28 or Fairbanks by road, railroad, or ferry shall be paid at a rate  
29 in the appropriate salary schedule two steps higher than [SIX PER

1 CENT ABOVE] the pay provided by sec. 10 of this chapter.

2 (3) The commissioner of administration shall promulgate  
3 regulations designating permanent duty stations which are eligible for  
4 pay increments under this section.
