6 For an Act entitled: "An Act appropriating for claims arising from damaged
7 boats during the Fairbanks flood of August, 1967; and
8 providing for an effective date."

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

10 * Section 1. The sum of \$28,287.15 is appropriated from the general fund
11 to compensate claims for damaged boats and motors during the Fairbanks flood
12 of August, 1967, according to the following amounts:
