6 For an Act entitled: "An Act relating to compensation of members of the
7 legislature and judicial officers; and providing for
8 an effective date."

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

10 * Section 1. AS 24.15.020 is repealed and re-enacted to read:

11 Sec. 24.15.020. LEGISLATIVE SALARIES. Each member of the
12 legislature shall receive an annual salary to be paid in 12 monthly
13 payments, each of which shall be equal in amount to 21 per cent of
14 the monthly salary of the governor. The president of the senate and
15 the speaker of the house of representatives shall each receive an
16 additional \$500 a year during tenure in office.

17 * Sec. 2. AS 22.05.140(a) is amended to read:

18 (a) The monthly salary of the chief justice is 95 per cent of
19 the monthly salary of the governor. The monthly salary of each
20 associate justice is 91 per cent of the monthly salary of the governor
21 [THE CHIEF JUSTICE SHALL RECEIVE \$27,000 ANNUALLY, AND EACH ASSOCIATE
22 JUSTICE SHALL RECEIVE \$26,000 ANNUALLY AS COMPENSATION. THE COMPEN-
23 SATION IS PAYABLE MONTHLY IN 12 EQUAL INSTALLMENTS]. Compensation of
24 the chief justice or of an associate justice shall not be diminished
25 during his term of office, unless by general law applying to all
26 salaried officers of the state.

27 * Sec. 3. AS 22.10.190(a) is amended to read:

28 (a) The monthly salary of each superior court judge is 83 per
29 cent of the monthly salary of the governor [EACH SUPERIOR COURT JUDGE

1 SHALL RECEIVE \$23,000 ANNUALLY, AS COMPENSATION, PAYABLE MONTHLY IN
2 12 EQUAL INSTALLMENTS]. The compensation of a judge shall not be
3 diminished during his term of office, unless by general law applying
4 to all salaried officers of the state.

5 * Sec. 4. AS 22.15.220(a) is repealed and re-enacted to read:

6 (a) The monthly salary of each district court judge is 61 per
7 cent of the monthly salary of the governor.

8 * Sec. 5. This Act takes effect on the day the annual salary of the
9 governor is increased to more than \$30,000.
