6 For an Act entitled: "An Act amending the Business License Act; and
7 providing for an effective date."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

9 * Section 1. AS 43.70.020(d) is amended to read:

10 (d) A person engaging in a business subject to licensing
11 provisions of a regulatory nature (for example, the requirement of
12 posting a bond before beginning business as a collection agency)
13 including the registration by professional people with boards such
14 as may be required by statute must, in addition to filing the regular
15 application required by this section, first comply with those
16 regulatory provisions before being entitled to a license under this
17 chapter.

18 * Sec. 2. AS 43.70.030(a) is repealed and re-enacted to read:

19 (a) The license fee for each business license issued for

20 (1) 1970 is \$25 plus a sum equal to four-tenths of one
21 per cent of that portion of a business' 1970 gross receipts between
22 \$20,000 and \$100,000 and two-tenths of one per cent of that portion
23 above \$100,000;

24 (2) 1971 is \$25 plus a sum equal to three-tenths of one
25 per cent of that portion of a business' 1971 gross receipts between
26 \$20,000 and \$100,000 and three-twentieths of one per cent of that
27 portion above \$100,000;

28 (3) 1972 is \$25 plus a sum equal to two-tenths of one
29 per cent of that portion of a business' 1972 gross receipts between

1 \$20,000 and \$100,000 and one-tenth of one per cent of that portion
2 above \$100,000;

3 (4) 1973 is \$25 plus a sum equal to one-tenth of one per
4 cent of that portion of a business' 1973 gross receipts between
5 \$20,000 and \$100,000 and one-twentieth of one per cent of that portion
6 above \$100,000;

7 (5) each year after 1973 is \$25.

8 * Sec. 3. AS 43.70.030 is amended by adding a new subsection to read:

9 (e) The annual license fee paid by a professional person to
10 his professional board shall be credited against the initial fee of
11 \$25 required under this chapter.

12 * Sec. 4. AS 43.70.110(1) is amended to read:

13 (1) "Business" includes all activities or acts, personal,
14 professional, or corporate, engaged in or caused to be engaged in, or
15 following or engaging in a trade, profession, or business, including
16 receipts from advertising services, rental of personal or real
17 property, construction, processing, or manufacturing, but excluding
18 fisheries businesses licensed under AS 43.75, fishermen, liquor
19 licenses, insurance businesses, mining, and coin-operated amusement
20 and gaming machines, calling or vocation, with the object of financial
21 or pecuniary gain, profit or benefit, either direct or indirect, and
22 not exempting subactivities producing marketable commodities or
23 services used or consumed in the main business activity, each of
24 which subactivities shall be considered business. The giving or
25 supplying of services as an employee and the furnishing of property,
26 services, substances, or things, by a person who does not hold
27 himself out anywhere as regularly engaging in those transactions,
28 does not constitute business under the meaning of this chapter.

29 * Sec. 4. This Act takes effect on the day after its passage and
