6 For an Act entitled: "An Act creating the Chugach State Park."

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

8 * Section 1. AS 41.20 is amended by adding new sections to read:

9 ARTICLE 5. CHUGACH STATE PARK.

10 Sec. 41.20.170. DECLARATION OF PURPOSE. The purpose of secs.
11 170 - 210 of this chapter is to restrict state-owned lands and waters
12 described in sec. 180 of this chapter to use as a state park. Under
13 the provisions of AS 38.05.300, state land, water or land and water
14 containing more than 640 acres may be closed to multiple purpose use
15 only by act of the legislature. Because the area described in sec. 180
16 of this chapter exceeds 640 acres, secs. 170 - 210 of this chapter are
17 intended to provide for the closing of the described lands and
18 waters to multiple purpose use in conformity with AS 38.05.300 and
19 their subsequent designation as a special purpose site in accordance
20 with art. VIII, sec. 7, of the Constitution of the State of Alaska.

21 Sec. 41.20.180. DESIGNATED STATE LAND AND WATER RESTRICTED TO
22 USE AS A STATE PARK. The presently state-owned lands and waters, and
23 all those acquired in the future by the state, lying within the
24 parcels described in this section are designated as the Chugach State
25 Park. The park is established to protect and supply a satisfactory
26 water supply for the use of the people, to provide recreational oppor-
27 tunities for the people by providing areas for specified uses and
28 constructing the necessary facilities in those areas, to protect areas
29 of unique and exceptional scenic value, to provide areas for the public

1 display of local wildlife where it shall be protected from hunting ex-
2 cept as otherwise required to preserve the habitat on the advice of
3 the Department of Fish and Game, and to protect the existing wilderness
4 characteristics of the easterly interior area. The eastern area of the
5 park shall be operated as a wilderness area, the central area as a
6 scenic area, and the periphery areas as recreational areas. The lands
7 and waters designated as the Chugach State Park and reserved from all
8 uses incompatible with their primary function as a state park are those
9 within the following described parcels excluding valid entries:
