6 For an Act entitled: "An Act relating to licenses by endorsement and
7 temporary permits for nurses; and providing for
8 an effective date."

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

10 * Section 1. AS 08.68.200 is amended to read:

11 Sec. 08.68.200. LICENSE BY ENDORSEMENT [FOREIGN LICENSEES].

12 The board may issue either a license to practice professional nursing
13 or a license to practice practical nursing, whichever is appropriate,
14 to an applicant for a license by endorsement who is licensed as
15 either a professional nurse or a practical nurse under the laws of
16 another state, territory, or foreign country, if in the opinion of
17 the board the applicant meets the qualifications required for
18 licensing in the state, and meets the requirements of either sec.
19 [SECS.] 170 or [AND] sec. 180 of this chapter, whichever is
20 applicable.

21 * Sec. 2. AS 08.68.210 is repealed and re-enacted to read:

22 Sec. 08.68.210. TEMPORARY PERMITS. (a) The board may issue
23 a temporary permit, nonrenewable and valid for a period not exceeding
24 four months, to an applicant for a license by endorsement if he
25 (1) submits proof satisfactory to the board that he is currently
26 licensed in another state, territory, or foreign country, (2) meets
27 the requirements of either sec. 170 or sec. 180 of this chapter,
28 whichever is applicable, and (3) pays the required fee.

29 (b) The board may issue a nonrenewable permit to an applicant

1 for license by examination if he meets the qualifications of sec. 170
2 or sec. 180 of this chapter, whichever is applicable, and pays the
3 required fee. The permit will be valid for a period not extending
4 beyond the time when the results are published of the first examination
5 the applicant is eligible to take after the permit is issued.

6 * Sec. 3. AS 08.68.220(1)(C) is amended to read:

7 (C) license by endorsement [RECIPROCITY] fee \$20

8 * Sec. 4. AS 08.68.220(2)(C) is amended to read:

9 (C) license by endorsement [RECIPROCITY] fee \$15

10 * Sec. 5. This Act takes effect on the day after its passage and
11 approval or on the day it becomes law without approval.
