6 For an Act entitled: "An Act relating to compensation of judicial,
7 executive, legislative officers and state employees;
8 and providing for an effective date."

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

10 * Section 1. AS 22.05.140(a) is amended to read:

11 (a) The chief justice [SHALL RECEIVE \$30,000 ANNUALLY,] and each
12 associate justice shall receive \$36,500 [\$28,000] annually as compen-
13 sation. The compensation is payable monthly in 12 equal installments.
14 Compensation of the chief justice or of an associate justice shall
15 not be diminished during his term of office, unless by general law
16 applying to all salaried officers of the state.

17 * Sec. 2. AS 22.10.190(a) is amended to read:

18 (a) Each superior court judge shall receive \$32,000 [\$26,500]
19 annually, as compensation, payable monthly in 12 equal installments.
20 The compensation of a judge shall not be diminished during his term
21 of office, unless by general law applying to all salaried officers
22 of the state.

23 * Sec. 3. AS 22.15.220(a) is repealed and re-enacted to read:

24 (a) Each district judge shall receive \$25,000 [\$19,000] annually
25 as compensation, payable monthly in 12 equal installments.

28 of the governor is \$40,000 [\$32,000]. The salary shall be paid in

10 increments as comparable as possible to those provided the classified
11 employees in sec. 7 of this Act.

13 Sec. 24.15.020. ANNUAL LEGISLATIVE SALARIES. The annual salary
14 for each member of the legislature is \$9,000 [\$6,000] to be paid in
15 approximately equal monthly payments. The president of the senate and
16 speaker of the house of representatives are each entitled to an
17 additional \$1,000 [\$500] a year during tenure of office.

18 * Sec. 10. AS 24.15.030 is amended to read:

19 Sec. 24.15.030. ADDITIONAL EXPENSE ALLOWANCES. In addition, each
20 member of the legislature is entitled to an annual expense allowance
21 of \$4,000 [\$1,000] for postage, stationery, stenographic services and
22 other expenses, which shall include but not be limited to travel
23 expenses.
