6 For an Act entitled: "An Act relating to compensation of judicial, execu-
7 tive, and state employees; and providing for an
8 effective date."

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

10 * Section 1. AS 22.05.140(a) is amended to read:

11 (a) The chief justice [SHALL RECEIVE \$30,000 ANNUALLY,] and
12 each associate justice shall receive \$33,000 [\$28,000] annually as
13 compensation. The compensation is payable monthly in 12 equal in-
14 stallments. Compensation of the chief justice or of an associate
15 justice shall not be diminished during his term of office, unless by
16 general law applying to all salaried officers of the state.

18 (a) Each superior court judge shall receive \$30,000 [\$26,500]
19 annually, as compensation, payable monthly in 12 equal installments.
20 The compensation of a judge shall not be diminished during his term
21 of office, unless by general law applying to all salaried officers
22 of the state.
