6 For an Act entitled: "An Act relating to people-teacher ratios."

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

8 * Section 1. AS 14.17.040 is amended by adding a new subsection to
9 read:

10 (4) the teacher aide salary allotment (sec. 55 of this
11 chapter).

12 * Sec. 2. AS 14.17.050(d) is amended to read:

13 (d) Each district is entitled to the number of teacher units for
14 elementary schools which corresponds to the average daily membership
15 for its elementary schools in the following elementary schedule. Each
16 district is entitled to the number of teacher units for secondary
17 schools which corresponds to the average daily membership for its
18 secondary schools in the following secondary schedule. If a school
19 district has two or more secondary attendance centers, it shall
20 separately compute the allowable number of teacher units for each of
21 its secondary attendance centers which has an average daily membership
22 of 301 or more pupils. Each district is entitled to the number of
23 teacher units for special education which corresponds to the average
24 daily membership for its special education program in the following
25 special education schedule.

(j) Each school district is entitled to additional teacher units as an allowance for ancillary persons or positions on the basis of one teacher unit for every 500 students or fraction of 500 students.
