For an Act entitled: "An Act relating to guides; and providing for an effective date."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

* Section 1. AS 16.50 is amended by adding a new section to read:

Sec. 16.50.130. QUALIFICATIONS FOR CLASS-A ASSISTANT GUIDE

LICENSE. A person is entitled to be licensed as a class-A assistant guide if he

12

(1) has been employed for at least one season as a licensed

14

assistant guide;

15

(2) has had at least 20 years experience in the guide

16

district in which he is to be employed; for the purposes of this para-

17

graph, physical presence at some time of year during each of 20 years

18

constitutes adequate evidence of experience, and military service out-

19

side the state for no more than six years shall be accepted as part

20

of the required 20 years experience;

21

(3) has been recommended in writing as qualified by a regis-

22

tered or master guide to the Department of Fish and Game.

Sec. 16.50.132. PRIVILEGES AND LIMITATIONS OF CLASS-A ASSISTANT

GUIDES. A class-A assistant guide

(3) may take charge of a camp and conduct hunts from it without the registered or master guide necessarily being present in the area if the registered or master guide is physically present in the state and is actively participating in guiding activities.

Sec. 16.50.140. RESPONSIBILITY OF REGISTERED OR MASTER GUIDE FOR VIOLATIONS. A registered or master guide contracting for a hunt is equally responsible for a violation of a federal or state sport fish, game or guide statute or regulation committed by a class-A assistant guide or assistant guide while in the course of his employment.

* Sec. 4. AS 16.50.145 is amended to read:

Sec. 16.50.145. FEES. (a) License fees for engaging in the profession of guiding are:

- (1) outfitter's license \$10
- (2) master guide license 50
- (3) registered guide license 50
- (4) assistant guide license 5
- (5) class-A assistant guide license 10

(b) The license fee for an outfitter, master guide, registered guide, class-A assistant guide, or assistant guide license shall be in addition to the fee required for a hunting or fishing license.

* Sec. 5. AS 16.50.155 is amended to read:

Sec. 16.50.155. EXPIRATION AND RENEWAL. (a) An outfitter, master guide, registered guide, class-A assistant guide, or assistant guide license expires on December 31, following issuance.

(b) A license may not be issued to an outfitter, master guide, registered guide, class-A assistant guide, or assistant guide who has failed to renew his license for two consecutive years unless he again meets the qualifications for initial issuance of the license.
