6 For an Act entitled: "An Act revising the state manpower training program;
7 and providing for an effective date."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

9 * Section 1. AS 23.15.611(b) is amended to read:

10 (b) The Department of Labor may [SHALL] expend funds [SOLELY]
11 for the payment of transportation, subsistence and training allowances
12 to trainees, incentive payments to employers who have contracted to
13 employ workers under the on-the-job training provisions of the Manpower
14 Development and Training Act of 1962 as amended, and for necessary
15 administrative costs of the department in carrying out the program.
16 If [THE] allowance payments are granted to trainees they will be paid
17 in an amount not exceeding the [ACCORDANCE WITH] guidelines provided
18 by the U. S. Manpower Development and Training Act of 1962 as amended,
19 and by regulations promulgated by the Department of Labor.

20 * Sec. 2. AS 23.15 is amended by adding a new section to read:

21 Sec. 23.15.612. MANPOWER TRAINING DIVISION. There is in the De-
22 partment of Labor the manpower training division, which is administered
23 by a director responsible to the commissioner. The director shall
24 administer sec. 611 of this chapter.

25 * Sec. 3. AS 23.15 is amended by adding a new section to read:

26 Sec. 23.15.613. MANPOWER TRAINING ADVISORY COUNCIL. (a) There
27 is the Manpower Training Advisory Council consisting of

28 (1) the commissioner of labor or his representative, who
29 shall be chairman;

- 1 (2) the commissioner of education or his representative;
- 2 (3) the commissioner of health and welfare or his repre-
- 3 sentative;
- 4 (4) the commissioner of economic development or his repre-
- 5 sentative;
- 6 (5) the commissioner of administration or his representative
- 7 (6) the director of division of research and planning or
- 8 his representative;
- 9 (7) three members representing labor;
- 10 (8) three members representing industry.

11 (b) The members representing industry and the members representing
12 labor will be appointed by the governor, will serve for a term of three
13 years, and will be entitled to the same per diem and expenses as
14 members of other boards and commissions.

15 (c) The council will

- 16 (1) advise the director of the division of manpower training
17 as to economic development and the manpower training needs of the state;
- 18 (2) collect data on the extent of unemployment and its
19 causes, and may hold hearings throughout the state from time to time
20 for this purpose;
- 21 (3) recommend to the governor action that executive agencies
22 should take under existing law to alleviate unemployment;
- 23 (4) urge necessary changes in military procurement and
24 construction policies;
- 25 (5) cooperate with federal and independent agencies;
- 26 (6) present a comprehensive report of its activities to the
27 members of the legislature at the start of each legislative session;
- 28 (7) emphasize through publicity and persuasion the importance
29 and desirability of hiring residents of the state to the fullest extent

(d) The council will meet at least twice a year.
