6 For an Act entitled: "An Act relating to departmental boards."

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

8 * Section 1. AS 39.05.060 is amended to read:

9 Sec. 39.05.060. APPOINTMENT, QUALIFICATIONS, AND TERMS OF OFFICE
10 OF MEMBERS OF DEPARTMENTAL BOARDS, COUNCILS, OR COMMISSIONS. Each
11 member of the Local Boundary Commission, Alcoholic Beverage Control
12 Board, Employment Security Advisory Council, Alaska State Housing
13 Authority, Board of Fish and Game, [BOARD OF TOURISM] and the Commission
14 for Northern Operations of Rail Transportation and Highways, shall be a
15 citizen of the United States. The governor shall appoint each member on
16 the basis of interest in public affairs, good judgment, knowledge and
17 ability in the field of action of the department for which appointed, and
18 with a view to providing diversity of interest and points of view in
19 the membership. Appointments are subject to confirmation by a majority
20 of the members of the legislature in joint session. Initial appointments
21 of members are as follows: (1) in the case of three-member boards, for
22 one, two and three years; (2) in the case of five-member boards, for
23 one, two, three, four and five years; (3) in the case of six-member
24 boards, two members serve for one year, two for two years, and two for
25 three years; (4) and in the case of eight-member boards, two members
26 serve for one year, two for two years, two for three years, and two for
27 four years; (5) and in the case of 10-member boards, two members serve
28 for one year, two for two years, two for three years, two for four years,
29 and two for five years. Initial terms date from February 1 before

1 appointment. A vacancy occurring during a term of office is filled in
2 the same manner as the original appointment is made and for the balance
3 of the unexpired term. Each member holds office at the pleasure of the
4 governor notwithstanding the member's term.

5 * Sec. 2. AS 23.30.005(a) is amended to read:

6 (a) The Alaska Workmen's Compensation Board shall consist of five
7 members, including a southern panel of three members sitting for the
8 first judicial district and a northern panel of three members sitting
9 for the second, third and fourth judicial districts. Each panel shall
10 include the commissioner of labor or his designated representative, a
11 representative of industry and a representative of labor. The latter
12 two members of each panel shall be appointed by the governor. All
13 panel members are subject to confirmation by a majority of the members
14 of the legislature in joint session.

15 * Sec. 3. AS 33.15.010 is amended to read:

16 Sec. 33.15.010. STATE BOARD OF PAROLE. There is in the department
17 a board of parole consisting of five members to be appointed by the
18 governor, subject to confirmation by a majority of the members of the
19 legislature in joint session. One of the members, who shall be chairman
20 of the board, shall be a person with training or experience in the field
21 of probation and parole, and he may be an official or employee of the
22 department but may not be an official or employee of the youth and
23 adult authority. The term of each of the other four members of the
24 board is four years and until his successor is appointed and qualifies.
25 Successors are appointed in the same manner as provided for the board
26 members first appointed. A vacancy shall be filled for the unexpired
27 term.
