6 For an Act entitled: "An Act relating to the purchase of services for
7 persons for whom the state has assumed responsibility."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

9 * Section 1. AS 47 is amended by adding a new chapter to read:

10 CHAPTER 40. PURCHASE OF SERVICES FROM FOSTER PARENTS, CHILD CARE
11 AND NURSING HOME INSTITUTIONS AND AGENCIES.

12 Sec. 47.40.010. PURCHASE OF SERVICES. When the Department of
13 Health and Welfare purchases services from foster parents, child care
14 and nursing home institutions and agencies for persons for whom the
15 state has assumed responsibility under the laws of the state, the de-
16 partment shall pay the full cost of the services at a level of care
17 established by regulations adopted by the department.

18 Sec. 47.40.020. REQUIRED ACCOUNTING PROCEDURES. Foster homes,
19 child care and nursing home institutions and agencies which receive
20 funds from the Department of Health and Welfare for the cost of ser-
21 vices provided under this chapter shall record and report to the de-
22 partment their financial activities according to instructions issued
23 by the department in advance of scheduled meetings provided for under
24 AS 47.05.010(14).

25 Sec. 47.40.030. DETERMINATION OF FULL COST OF SERVICES. (a) In
26 this chapter, "full cost" of services is all expenses related directly
27 to providing the services determined to be required for a person by
28 the Department of Health and Welfare under the regulations adopted by
29 the department. Placement of persons shall be made by the department

1 in accordance with the various levels of care necessary under the
2 classification standards and regulations adopted by the department.
3 Full cost shall be determined by the per-person, per-day cost incurred
4 in the preceding fiscal year plus a proportionate share of anticipated
5 cost of living, salary and other increases for the fiscal year for
6 which the full cost of services, determined to be necessary by the
7 department, is being determined. Child care costs for foster homes
8 shall be computed in the same manner as for child care and nursing home
9 institutions and agencies except that no salary costs may be con-
10 sidered.

11 (b) Full cost of services does not include the following:

12 (1) expenses, including salaries and fees, incurred in
13 raising funds;

14 (2) funds expended for construction, major equipment and
15 other capital expenditures;

16 (3) depreciation and replacement costs of, and costs of
17 additions to, major property and equipment if funds for these purposes
18 have not actually been set aside;

19 (4) religious training and education; and

20 (5) services provided which are determined by the department
21 to be above a reasonable and necessary level of care.
