For an Act entitled: "An Act relating to the use of firearms in designated
7 state parks; and providing for an effective date."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

* Section 1. AS 11.55.050 is amended by adding a new subsection to read:

10

(b) Notwithstanding the provisions in (a) of this section,

11

firearms may be used in those state parks which are by statute, or by

12

lawful regulation, open to shooting.

* Sec. 2. AS 41.20.230(c) is amended to read:

(c) Discharge of [EXCEPT FOR AREAS WITHIN ONE MILE OF MAINTAINED

15

ROADS, TRAILS AND CAMP GROUNDS, HUNTING WITH] a firearm is permitted

16

in Chugach State Park when authorized by lawful regulation by the

17

Department of Natural Resources [BOARD OF FISH AND GAME UNDER AS 16.05,

18

IS NOT SUBJECT TO THE PROVISIONS OF AS 11.55.050 WHICH PROHIBIT THE

DISCHARGE OF A FIREARM IN A PUBLIC PARK].

Sec. 41.99.010. GAME MANAGEMENT AND ENFORCEMENT. Nothing in

1 this title denies the Department of Fish and Game or the Board of Fish
2 and Game their management and enforcement responsibilities related to
3 the fish and game of this state.

4 * Sec. 5. This Act takes effect on the day after its passage and
5 approval or on the day it becomes law without approval.
