6 For an Act entitled: "An Act relating to Chugach State Park."

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

8 * Section 1. PURPOSE. It is the purpose of this Act to enlarge the
9 boundaries of Chugach State Park by including in it undeveloped lands within
10 the Anchorage borough primarily comprising areas previously within Campbell
11 Airstrip Reservation and glaciated mountain land east of the existing park
12 which includes a registered national landmark and which, at the time of the
13 original land selection for the park, was unavailable. It is also the
14 purpose of this Act to exclude from designation as part of the Chugach State
15 Park all lands lying within the city limits of Girdwood, Alaska.
