5 A BILL

6 For an Act entitled: "An Act creating the Ester Dome Recreation Area; and
7 providing for an effective date."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

9 * Section 1. AS 41.20 is amended by adding new sections to read:

10 Sec. 41.20.320. DESIGNATED STATE LAND RESTRICTED TO USE AS A
11 RECREATION AREA. Lands which are state-owned as of the effective date
12 of this Act, and all those acquired in the future by the state, lying
13 within the parcels described in sec. 325 of this chapter are designated
14 as the Ester Dome Recreation Area. In order to protect and preserve
15 these lands the area is established and shall be managed as a recreation
16 area.

17 Sec. 41.20.325. DESIGNATION OF AREA. (a) The lands lying within
18 the following described parcels are reserved from all uses incompatible
19 with their primary function as a recreation area and are assigned to the
20 Department of Natural Resources for control, development and maintenance
21 in accordance with sec. 320 of this chapter:

22 (1) Township 1 North, Range 3 West, Fairbanks Meridian

23 Section 24: S 1/2 except USS 4004

24 Section 25: E 1/2 except USS 4012 and Lot 1 USS
25 5628

26 Section 25: SW 1/4

27 Section 34: S 1/2

28 Section 35

29 Section 36: S 1/2 and SW 1/4

1 Section 36: NE 1/4 and SE 1/4

2 Section 36: SW 1/4 and SW 1/4

3 Section 36: NW 1/4 and SW 1/4 except R/W 44LD513

4 Section 36: S 1/2 and NE 1/4 except Lots 2, 3 and
5 4 USS 5628

6 Section 36: S 1/2 and NE 1/4 except Lots 4 and 5
7 USS 5628

8 Section 36: SE 1/4 and NW 1/4 except R/W 44LD 513

9 Section 36: SW 1/4 and NW 1/4 except R/W 44LD

10 Section 36: N 1/2 and NW 1/4 except R/W 44LD513

11 Section 36: NW 1/4 and NE 1/4 except Lots 3, 4 and
12 5 USS 5628 and R/W 44LD513

13 (2) Township 1 North, Range 2 West, Fairbanks Meridian

14 Section 30: S 1/2 except USS 4004

15 Section 30: NW 1/4

16 Section 31: N 1/2 except USS 4004

17 Section 31: SE 1/4

18 Section 31: NE 1/4 and SW 1/4

19 (b) Lands lying within the parcels described in (a) of this
20 section which have been withdrawn before the effective date of this
21 Act, or lands lying within the parcels described in (a) of this section
22 upon which there are valid entries or upon which there are valid appli-
23 cations for leases filed under AS 38.05 before the effective date of
24 this Act are excepted from (a) of this section; however, if any lands
25 excepted under this subsection are subsequently relinquished to the
26 state, they shall be included as part of the Ester Dome Recreation
27 Area.

28 Sec. 41.20.330. INCOMPATIBLE USES PROHIBITED. The commissioner
29 of natural resources shall designate by regulation incompatible uses

1 within the boundaries of the Ester Dome Recreation Area and those
2 incompatible uses designated shall be prohibited or restricted, as
3 provided by regulation.

4 Sec. 41.20.335. PURCHASE AUTHORIZED. The commissioner of natural
5 resources may acquire, by purchase, within the limits of available
6 appropriations, in the name of the state, title to or interest in
7 real property lying within the boundaries of the Ester Dome Recreation
8 Area. The state may not acquire by eminent domain privately owned
9 land for inclusion in the Ester Dome Recreation Area.

10 * Sec. 2. This Act takes effect on the date after its passage and
11 approval or on the day it becomes law without approval.
