6 For an Act entitled: "An Act creating a division of reindeer affairs and a
7 reindeer affairs board in the Department of Economic
8 Development."

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

10 * Section 1. AS 44.45 is amended by adding new sections to read:

11 ARTICLE 6. DIVISION OF REINDEER AFFAIRS.

12 Sec. 44.45.161. DIVISION OF REINDEER AFFAIRS. The division of
13 reindeer affairs shall:

- 14 (1) cooperate with organizations which represent Alaska
15 reindeer herdsmen to inventory reindeer herds;
- 16 (2) assist potential herdsmen in finding financial support
17 for the development of the reindeer industry;
- 18 (3) promote and develop the reindeer industry of this state
19 through publication of advertising in magazines, newspapers, over
20 radio and television, and through other advertising media, and by
21 publishing pamphlets, brochures, and other graphic and pictorial
22 materials;
- 23 (4) stimulate the interest of the citizens of Alaska in the
24 economic importance of the reindeer industry;
- 25 (5) carry out project feasibility analyses to serve as
26 bases for improving the reindeer industry;
- 27 (6) negotiate with potential herdsmen as to studies and
28 other activities under this chapter which are useful to the potential
29 herdsmen;

1 (7) provide technical assistance to potential herdsmen
2 by drawing on professional, specialized, and technical employees of
3 the department and other agenices;

4 (8) enter into research contracts with the University of
5 Alaska and private research organizations, and otherwise cooperate
6 with appropriate public and private institutions in research and
7 investigations to carry out the purposes of this chapter.

8 Sec. 44.45.163. REINDEER AFFAIRS BOARD. There is the reindeer
9 affairs board in the Department of Economic Development.

10 Sec. 44.45.165. COMPOSITION AND ORGANIZATION. (a) The reindeer
11 affairs board consists of nine members appointed by the governor for
12 overlapping three-year terms. Members of the board shall be persons
13 with experience in the reindeer industry and at least five members
14 shall be engaged in the occupation of reindeer herding.

15 (b) Five members of the board constitute a quorum for the
16 transaction of business of the board.

17 (c) The chairman of the board shall be elected by the members.

18 Sec. 44.45.167. COMPENSATION, PER DIEM OR EXPENSES. Members of
19 the reindeer affairs board receive no salary for their service on the
20 board but are entitled to per diem and travel expenses authorized by
21 law for boards and commissions.

22 Sec. 44.45.169. DUTIES. The board shall advise and make recom-
23 mendations to the department in regard to the promotion and development
24 of reindeer husbandry and the reindeer industry in Alaska.

25 ARTICLE 8. GENERAL PROVISIONS.

26 Sec. 44.45.900. DEFINITIONS. In this chapter

27 (1) "department" means the Department of Economic Development

28 (2) "commissioner" means the commissioner of economic
29 development.
