6 For an Act entitled: "An Act relating to postsecondary education; and  
7 providing for an effective date."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

9 \* Section 1. AS 14.40.685 is amended to read:

10 Sec. 14.40.685. PROVISIONS OF SERVICES. State participation  
11 under Articles VIII and XIII of the Western Regional Higher Education  
12 Compact shall be limited to the provision of adequate services and  
13 facilities in the fields of law, dentistry (to include dental hygiene),  
14 medicine, public health, [AND] veterinary medicine, pharmacy, physical  
15 therapy, occupational therapy, optometry, podiatry, forestry and  
16 graduate library studies.

17 \* Sec. 2. AS 14.40 is amended by adding a new section to read:

18 Sec. 14.40.695. ADMINISTRATION. The Alaska Commission on Post-  
19 secondary education shall administer the state's participation in the  
20 Western Regional Higher Education Compact.

21 \* Sec. 3. On the effective date of this Act, the administration of the  
22 state's participation in the Western Regional Higher Education Compact (AS  
23 14.40.660 - 14.40.695) shall be transferred from the Office of the Governor  
24 to the Alaska Commission on Postsecondary Education.

25 \* Sec. 4. AS 14.40 is amended by adding new sections to read:

26 ARTICLE 11. ALASKA COMMISSION ON POSTSECONDARY EDUCATION.

27 Sec. 14.40.901. PURPOSE, INTENT. (a) The legislature finds and  
28 declares that it has become essential for Alaska to provide for a more  
29 efficient use of financial resources, both federal and state, in pro-
