5 A BILL

6 For an Act entitled: "An Act increasing sport and commercial license fees;
7 and providing for an effective date."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

9 * Section 1. AS 16.05.340(a) is amended to read:

10 (a) Fees for licenses and tags are as follows:

11 (1) Resident sport fishing license.....\$ 10 [5]

12 However, the fee is \$2 [\$1] for a resident who is blind.

13 (2) Resident hunting license..... 7

14 (3) (A) Resident hunting and trapping license... 10

15 (B) Resident trapping license..... 3

16 (4) Resident hunting and sport fishing license... 17 [12]

17 (5) Resident hunting, trapping, and sport
18 fishing license..... 20 [15]

19 However, the fee is 25 cents for the head of a family or a dependent
20 member of his family or one solely dependent upon himself for support
21 upon proof presented by the applicant that the applicant (A) is
22 obtaining or has obtained assistance during the preceding six months
23 under any state or federal welfare program to aid the indigent, or (B)
24 has an annual family gross income of less than \$3,600 for the year
25 preceding application.

26 (6) Visitor's special sport fishing license - valid
27 for the 10-day period inscribed on the license..... 20 [10]

28 (7) Nonresident sport fishing license..... 40 [20]

29 (8) Nonresident hunting license..... 20

1 (9) Nonresident hunting and sport fishing license... 60 [40]

2 A nonresident may not take a big game animal without previously pur-
3 chasing a numbered, nontransferable, appropriate tag, issued to him
4 as provided in (16) of this subsection. The tag shall be affixed to
5 the animal immediately upon taking and shall remain affixed until the
6 animal is prepared for storage, consumed, or exported.

6 (a) A person engaged in commercial fishing shall obtain a commercial fishing license. The fee for the license is \$20 [\$10] for residents, and \$60 [\$30] for nonresidents. All commercial fishing licenses are nontransferable and shall be retained in the possession of the licensee, readily accessible for inspection at all times.

12 Sec. 16.05.530. ANNUAL RENEWAL OF VESSEL LICENSE. Upon annual
 13 payment of a license fee of \$20 [\$10] for a resident and \$60 [\$30] for a
 14 nonresident, and filing of the name and address of the owner and opera-
 15 tor of the vessel, the name and number of the vessel, a description of
 16 the vessel and fishing gear, vessel license number, if any, the area
 17 to be fished, and other reasonable information required by the Depart-
 18 ment of Revenue, the Department of Revenue shall issue a number plate
 19 and a vessel license. If the vessel has a number plate, the Department
 20 of Revenue shall issue a vessel license and tab designating the year.
 21 The tab shall be placed in the space provided on the permanent number
 22 plate.

1 for set or long lines used in the taking or catching of fish for com-
2 mercial purposes in the waters of the state. The fee is \$50 [\$25] a
3 year for residents and \$100 [\$50] a year for nonresidents.

4 * Sec. 6. AS 16.05.570 is amended to read:

5 Sec. 16.05.570. DRIFT GILL NET LICENSE. A license is required for
6 drift gill nets used in the taking or catching of fish for commercial
7 purposes in the waters of the state. The fee is \$20 [\$10] a year for
8 the first 100 fathoms or fraction thereof and \$10 [\$5] for each addition-
9 al 50 fathoms or fraction thereof for a resident and \$60 [\$30] a year
10 for the first 100 fathoms or fraction thereof and \$30 [\$15] for each
11 additional 50 fathoms or fraction thereof for a nonresident, provided
12 only the maximum amount of gear fished at one time is licensed. The
13 gear for each vessel shall be separately licensed.

14 * Sec. 7. AS 16.05.580 is amended to read:

15 Sec. 16.05.580. SET OR STAKE GILL NET LICENSE. A license is re-
16 quired for a set or stake gill net used in the taking or catching of
17 fish for commercial purposes in the waters of the state. The fee is
18 \$10 [\$5] a year for the first 50 fathoms or fraction thereof and \$10
19 [\$5] for each additional 50 fathoms or fraction thereof for a resident
20 and \$30 [\$15] a year for the first 50 fathoms or fraction thereof and
21 \$30 [\$15] for each additional 50 fathoms or fraction thereof for a non-
22 resident, provided only the maximum amount of gear fished at one time
23 is licensed.

24 * Sec. 8. AS 16.05.590 is amended to read:

25 Sec. 16.05.590. BEACH OR DRAG SEINE LICENSE. A license is required
26 for each beach or drag seine used in the taking or catching of fish for
27 commercial purposes in the waters of the state. The fee is \$20 [\$10]
28 a year for the first 100 fathoms or fraction thereof and \$10 [\$5] for
29 each additional 50 fathoms or fraction thereof for a resident and \$60

1 [\$30] a year for the first 100 fathoms or fraction thereof and \$30 [\$15]
2 for each additional 50 fathoms or fraction thereof for a nonresident.

3 * Sec. 9. AS 16.05.600 is amended to read:

4 Sec. 16.05.600. PURSE SEINE AND HAND PURSE SEINE LICENSE. A li-
5 cense is required for purse seines and hand purse seines used in the
6 taking or catching of fish for commercial purposes in the waters of the
7 state. The fee is \$80 [\$40] a year for the first 100 fathoms or fraction
8 thereof and \$20 [\$10] for each additional 50 fathoms or fraction for a
9 resident and \$240 [\$120] a year for the first 100 fathoms or fraction
10 thereof and \$60 [\$30] for each additional 50 fathoms or fraction thereof
11 for a nonresident.

12 * Sec. 10. AS 16.05.610 is amended to read:

13 Sec. 16.05.610. BEAM TRAWL, OTTER TRAWL AND SCALLOP LICENSES. A
14 license is required for beam trawls and otter trawls used in the taking
15 or catching of fish or shellfish for commercial purposes and for use of
16 dredges in taking or catching scallops for commercial purposes in the
17 waters of the state. The fee is \$100 [\$50] a year for a resident and
18 \$300 [\$150] a year for a nonresident.

19 * Sec. 11. AS 16.05.620 is amended to read:

20 Sec. 16.05.620. OTTER TRAWL LICENSE. A license is required for
21 otter trawls used in the taking or catching of fish or shellfish for
22 commercial purposes in the waters of the state. The fee is \$100 [\$50]
23 a year for a resident and \$300 [\$150] a year for a nonresident.

24 * Sec. 12. AS 16.05.630 is amended to read:

25 Sec. 16.05.630. SHELLFISH POT LICENSE. A license is required for
26 shellfish pots used in the taking or catching of shellfish for commer-
27 cial purposes in the waters of the state. For each 100 pots or less the
28 fee is \$30 [\$15] a year for a resident and \$90 [\$45] a year for a non-
29 resident. For each additional 100 pots or less the fee is \$30 [\$15] a

1 year for a resident and \$90 [~~\$45~~] a year for a nonresident.

2 * Sec. 13. AS 16.05.650 is amended to read:

3 Sec. 16.05.650. LICENSING OF SMALL COMMERCIAL OPERATIONS. A per-
4 son licensed as a commercial fisherman in this state who employs in
5 commercial fishing only one vessel which is not more than 16 feet in
6 length and has aboard one or more motors of no more than 10 horsepower
7 in the aggregate shall pay an annual vessel license of \$6 [~~\$3~~] and a
8 gear license of \$10 [~~\$5~~] for the use of troll lines, set lines, or long
9 lines as prescribed in secs. 550 - 560 of this chapter in taking or
10 catching fish for commercial purposes in the waters of the state.

11 * Sec. 14. In addition to other funds appropriated for the purpose
12 specified in this section, the legislature may appropriate an amount equal to
13 the added funds produced by the increase in license fees as a result of the
14 passage of this Act, for the management, restoration, and rehabilitation of
15 the fishery resources of the state.

16 * Sec. 15. This Act takes effect on the day after its passage and approval
17 or on the day it becomes law without approval.
