7 of employment in the classified and partially exempt
8 service of the State of Alaska; and providing for an
9 effective date."

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

11 * Section 1. AS 39.25 is amended by adding a new section to read:

12 Sec. 39.25.200. WORK WEEK. The standard work week for employees
13 in the classified and partially exempt service of the state is 40 hours.
14 Notwithstanding AS 23.40.250(1), the provisions of this section are
15 not subject to collective bargaining under the Public Employment Rela-
16 tions Act (AS 23.40.070 - 23.40.260).

* Sec. 4. This Act takes effect on the day after its passage and approval or on the day it becomes law without approval.
