5 A BILL

6 For an Act entitled: "An Act relating to the compensation of judicial and  
7 public officers; and providing for an effective date."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

9 \* Section 1. AS 22.05.140(a) is amended to read:

10 (a) The chief justice and each associate justice shall receive  
11 \$44,000 [\$36,000] annually as compensation. The compensation is  
12 payable monthly in 12 equal installments. Compensation of the chief  
13 justice or of an associate justice shall not be diminished during his  
14 term of office, unless by general law applying to all salaried officers  
15 of the state.

17 (a) Each superior court judge shall receive \$40,000 [\$33,000]  
18 annually, as compensation, payable monthly in 12 equal installments.  
19 The compensation of a judge shall not be diminished during his term of  
20 office, unless by general law applying to all salaried officers of the  
21 state.

22 \* Sec. 3. AS 22.15.220(a) is amended to read:

23 (a) Each district judge shall receive \$33,500 [\$27,500] annually  
24 as compensation, payable monthly in 12 equal installments.

25 \* Sec. 4. AS 22.15.220(b) is amended to read:

26 (b) Each magistrate shall receive annual compensation to be  
27 determined by the supreme court. Salary increases shall be determined  
28 on the basis of percentage of pay increase the legislature provides for  
29 state employees in the classified service. A magistrate's annual

1 compensation may be payable, at the option of the magistrate, either  
2 monthly in 12 equal installments or semi-monthly in 24 equal installments.

4 Sec. 39.20.010. ANNUAL SALARY OF GOVERNOR. The annual salary of  
5 the governor is \$50,000 [\$40,000]. The salary shall be paid in equal  
6 monthly installments.

7 \* Sec. 6. AS 39.20.030 is amended to read:

8 Sec. 39.20.030. ANNUAL SALARY OF LIEUTENANT GOVERNOR. The annual  
9 salary of the lieutenant governor is \$44,000 [36,000]. The salary  
10 shall be paid in equal monthly installments.

11 \* Sec. 7. AS 39.20.080(a) is amended to read:

12 (a) The annual salary of the head of each principal executive  
13 department of the state upon appointment and confirmation is \$40,000  
14 [\$33,000]. This salary shall be paid in equal monthly installments.

15 \* Sec. 8. Secs. 1, 2, 3, and 7 of this Act take effect on the day after  
16 its passage and approval or on the day it becomes law without approval.

17 \* Sec. 9. Secs. 5 and 6 of this Act take effect January 1, 1975.
