6 For an Act entitled: "An Act relating to traffic laws and regulations."

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

8 \* Section 1. AS 28 is amended by adding a new chapter to read:

9 CHAPTER 01. SCOPE AND INTERPRETATION OF TITLE.

10 Sec. 28.01.010. PROVISIONS UNIFORM THROUGHOUT STATE. (a) The  
11 provisions of this title and the regulations promulgated under this  
12 title are applicable within all political subdivisions of the state.  
13 No political subdivision may enact an ordinance which is inconsistent  
14 with the provisions of this title or the regulations promulgated under  
15 this title. A political subdivision may not incorporate into a  
16 publication of traffic ordinances a provision of this title or the  
17 regulations promulgated under this title without specifically identi-  
18 fying the provision or regulation as a state statute or regulation.

19 (b) Notwithstanding (a) of this section, a political subdivision  
20 may enact necessary ordinances to meet specific local requirements with  
21 the approval of the commissioner of public safety.

22 (c) A copy of all traffic ordinances enacted by a political sub-  
23 division shall be forwarded to the commissioner of public safety.

24 (d) A political subdivision shall erect necessary official traffic  
25 control devices on streets and highways within its jurisdiction which  
26 as far as practicable conform to the current edition of the Alaska  
27 Traffic Manual prepared by the Department of Highways.
