6 For an Act entitled: "An Act relating to the regents of the University of  
7 Alaska; and providing for an effective date."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

9 \* Section 1. AS 14.40.120 is amended to read:

10 Sec. 14.40.120. UNIVERSITY GOVERNED BY BOARD OF REGENTS. The  
11 University of Alaska shall be governed by a Board of Regents consisting  
12 of 11 [NINE] regents.

13 \* Sec. 2. AS 14.40.140 is amended to read:

14 Sec. 14.40.140. TERM OF OFFICE. Except for a student regent as  
15 specified in sec. 150(b) of this chapter, the term of office of a regent  
16 is five [EIGHT] years. The term of office beings on the first Monday in  
17 February of the year in which the appointment is made. Each regent  
18 serves until his successor is appointed and qualifies. No regent may  
19 serve more than two full five-year terms. However, if a regent is  
20 appointed to fill an unexpired term, he may complete that term and be  
21 reappointed to two successive full five-year terms. A regent who has  
22 completed two full five-year terms may not be reappointed to the board  
23 until one year has elapsed. No regent may serve more than two consecu-  
24 tive years as president of the board.

25 \* Sec. 3. AS 14.40.200 is amended to read:

26 Sec. 14.40.200. QUORUM. No corporate business may be transacted  
27 at any meeting of the Board of Regents unless at least six [FIVE] regents  
28 are present, the majority of the whole board to approve the same.

29 \* Sec. 4. Members of the Board of Regents of the University of Alaska

1 whose terms began, and who were confirmed, before February 3, 1975, shall  
2 serve for the balance of the term for which they were appointed. Members of  
3 the board whose terms begin, and who were confirmed, after February 2, 1975,  
4 shall serve for the term prescribed in AS 14.40.140, as amended by sec. 1 of  
5 this Act.

6 \* Sec. 5. This Act is retroactive to February 3, 1975.

7 \* Sec. 6. This Act takes effect immediately in accordance with AS 01.10.-  
8 070(c).
