6 For an Act entitled: "An Act relating to the appointment and compensation  
7 of local registrars and deputy local registrars of  
8 vital statistics."

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

10 \* Section 1. AS 18.50.080 is amended to read:

11 Sec. 18.50.080. APPOINTMENT OF LOCAL REGISTRARS. (a) Where  
12 feasible, the state registrar shall use the services of an employee of  
13 the department [A LOCAL RECORDING OFFICIAL] located within a registra-  
14 tion district as local registrar of vital statistics.

15 (b) Where utilization under (a) of this section is not feasible,  
16 the state registrar shall appoint a local registrar and may appoint one  
17 or more deputy local registrars of vital statistics for each registra-  
18 tion district, to be compensated on a fee basis as specified in sec. 120  
19 of this chapter. The state registrar may, with the approval of the  
20 administrative director of the Alaska Court System, appoint magistrates  
21 as local registrars and deputy local registrars of vital statistics.

22 (c) The state registrar may remove a local registrar or a deputy  
23 local registrar appointed under (b) of this section.

25 Sec. 18.50.120. COMPENSATION OF LOCAL REGISTRARS. When an  
26 employee of the department or a magistrate [A LOCAL RECORDING OFFICIAL]  
27 receiving a salary or other regular compensation from the state [FOR  
28 GENERAL RECORDING DUTIES] serves as a local registrar or deputy local  
29 registrar of vital statistics, he is not entitled to fees under this

1 section. Otherwise, local registrars and deputy local registrars of  
2 vital statistics shall be paid, from funds appropriated for this purpose,  
3 as follows:

4 (1) for a certificate of birth, death, fetal death, or  
5 marriage occurring in his registration district, properly completed and  
6 transmitted by him in accordance with the regulations and instructions  
7 issued under this chapter, \$2;

8 (2) for each monthly report indicating the number of the  
9 various vital events which occurred in his registration district,  
10 properly made in accordance with the regulations and instructions issued  
11 under this chapter, \$1.
