For an Act entitled: "An Act creating the Administrative Regulation Review
7 Committee."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

* Section 1. AS 24.20. is amended by adding new sections to read:

ARTICLE 3. ADMINISTRATIVE REGULATION REVIEW COMMITTEE.

Sec. 24.20.400. ADMINISTRATIVE REGULATION REVIEW COMMITTEE

ESTABLISHED. The Administrative Regulation Review Committee is estab-
13 lished as a permanent interim committee of the legislature. The
14 establishment of the committee recognizes the need for prompt legisla-
15 tive review of administrative regulations filed with the lieutenant
16 governor to determine whether annulment under AS 44.62.320 is appropriate.

Sec. 24.20.410. MEMBERSHIP. The Administrative Regulation

18

Review Committee is composed of three members of the house appointed
19 by the speaker of the house, and three members of the senate appointed
20 by the president of the senate. The membership from each house shall
21 include at least one member from each of the two major political
22 parties. The committee elects a chairman from among its members.

23

Sec. 24.20.420. TERM OF MEMBERSHIP. The committee shall be or-

24

ganized within 15 days after the organization of each legislature.

25

Members serve for the duration of the legislature during which they
26 are appointed. If they are reelected or their term of office extends
27 into the next succeeding legislature, they continue to serve until
28 reappointed or the appointment of their successor.

29

Sec. 24.20.430. VACANCIES. When a vacancy occurs in the member-

1 ship of the committee, the presiding officer of the house incurring
2 the vacancy shall choose a successor. If the office of the president
3 of the senate or speaker of the house of representatives becomes
4 vacant and a vacancy from the affected house occurs among the member-
5 ship of the committee, the remaining committee members from the house
6 incurring the vacancy shall appoint a new member.

7 Sec. 24.20.440. MEETINGS. The Administrative Regulation Review
8 Committee may meet during sessions of the legislature and during the
9 interim between sessions at such times and places in the state as the
10 chairman may determine. Members may receive, for the minimum time
11 required to get to and from meetings and for the period while attending
12 meetings, the same travel and per diem allowances provided by law for
13 members of the legislature when attending sessions, except that members
14 of the committee receive no per diem during legislative sessions other
15 than the per diem allowance paid to other members of the legislature.

16 Sec. 24.20.450. STAFF. The Legislative Affairs Agency shall
17 provide the committee with professional and clerical assistance under
18 the auspices of the Legislative Council.

19 Sec. 24.20.460. POWERS. The Administrative Regulation Review
20 Committee has the following powers:

- 21 (1) to organize and adopt rules for the conduct of its
22 business;
- 23 (2) to hold public hearings;
- 24 (3) to require all state officials and agencies of state
25 government to give full cooperation to the committee or its staff in
26 assembling and furnishing requested information;
- 27 (4) to examine all administrative regulations to determine
28 if they properly implement legislative intent;
- 29 (5) to make recommendations for legislative annulment of

(6) to prepare and distribute reports, memoranda, or other materials.

* Sec. 2. AS 44.62.320 is amended by adding a new subsection to read:

(b) Within 45 days after a regulation is filed with the lieutenant governor, the lieutenant governor shall submit the regulation to the chairman of the Administrative Regulation Review Committee for review under AS 24.20.400 - 24.20.460.
