6 For an Act entitled: "An Act making a supplemental appropriation to the
7 Department of Administration for state salaries; and
8 providing for an effective date."

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

10 * Section 1. The sum of \$1,371,000 is appropriated from the general fund
11 to the Department of Administration for fiscal year 1975, to pay the esti-
12 mated costs of the arbitrated 1975 contract for community college instructors.

13 * Sec. 2. The sum of \$5,845,400 is appropriated to the Department of
14 Administration for fiscal year 1975 to pay the unfunded costs related to
15 salary increases, primarily the cost-of-living allowance. The appropriation
16 is funded as follows:

24 * Sec. 3. The sum of \$4,228,400 is appropriated to the Department of
25 Administration for fiscal year 1975 to pay the salaries of state employees
26 covered by the general government contract settlement. The appropriation is
27 funded as follows:

14 * Sec. 4. The sum of \$2,652,800 is appropriated from the general fund to
15 the Department of Administration for fiscal year 1975 to pay the cost of
16 salary increases for state employees not covered by any collective bargaining
17 agreement.

18 * Sec. 5. Notwithstanding the provisions of AS 37.07.080(e) pertaining to
19 appropriation transfers, the division of budget and management is authorized
20 to transfer the appropriate amounts shown in secs. 1 - 4 of this Act between
21 program categories or agencies as required for salary increase purposes.

22 * Sec. 6. This Act takes effect immediately in accordance with AS 01.10.-
23 070(c).
