6 For an Act entitled: "An Act relating to the disclosure of ownership  
7 interests."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

9 \* Section 1. AS 09.25.010(b) is amended to read:

10 (b) No estate or interest in real property, other than a lease for  
11 a term not exceeding one year, nor any trust or power concerning the  
12 property may be created, transferred, or declared, otherwise than by  
13 operation of law, or by a conveyance or other instrument in writing  
14 subscribed by the party creating, transferring, or declaring it or by  
15 his agent under written authority and executed with the formalities that  
16 are required by law. If the estate or interest in real property is  
17 created, transferred or declared to a nonresident alien or for the  
18 benefit of a nonresident alien, the instrument shall so state and shall  
19 contain the name and address of the alien. This subsection does not  
20 affect the power of a testator in the disposition of his real property  
21 by will, nor prevent a trust's arising or being extinguished by impli-  
22 cation or operation of law, nor affect the power of a court to compel  
23 specific performance of an agreement in relation to the property.

26 Sec. 10.05.250. REORGANIZATION; DISCLOSURE OF ALIEN INTERESTS.

27 Not less than 20 days before the consummation of a corporate reorganiza-  
28 tion the corporation which is to survive or control shall deliver to  
29 the commissioner a list of the names and addresses of each affiliate of

1 the surviving corporation which is a nonresident alien or corporation  
2 whose place of incorporation is outside the United States, and the per-  
3 centage of outstanding shares controlled by each affiliate.

4 \* Sec. 3. AS 10.05.255(a) is amended by adding a new paragraph to read:

5 (13) the name and address of each affiliate which is a non-  
6 resident alien or a corporation whose place of incorporation is outside  
7 the United States.

14 (8) the name and address of each affiliate which is a non-  
15 resident alien or a corporation whose place of incorporation is outside

19 (18) "affiliate" means a person that directly or indirectly  
20 through one or more intermediaries controls, or is controlled by, or is  
21 under common control with, a corporation subject to this chapter;

22 (19) "controls" (including "controlling", "controlled by" and  
23 "under common control with") means the possession direct or indirect, of  
24 the power to direct or cause the direction of the management and policies  
25 of a person, whether through ownership of voting securities, by contract,  
26 or otherwise;

27 (20) "person" means an individual, a corporation, a partner-  
28 ship, an association, a joint-stock company, a trust where the interests  
29 of the beneficiaries are evidenced by a security, an unincorporated

1 organization, a government, or a political subdivision of a government;

2 (21) "reorganization" means a "reorganization" as that word is  
3 defined by sec. 368(a)(1)(A) - (D) of the Internal Revenue Code of 1954  
4 as it exists on the effective date of this Act.

5 \* Sec. 7. It is the intent of the legislature to adopt the definitions  
6 for "affiliate" and "control" as those terms are in use and have been inter-  
7 preted by the United States Securities Exchange Commission on the effective  
8 date of this Act.

9 \* Sec. 8. AS 22.15.110 is amended by adding a new paragraph to read:

10 (4) file with the commissioner of commerce a copy of each  
11 conveyance recorded which contains a statement that property is conveyed  
12 to a nonresident alien or for the benefit of a nonresident alien.

13 \* Sec. 9. AS 10.20.625 is amended by adding a new paragraph to read:

14 (5) the real and personal property assets of the corporation.

15 \* Sec. 10. AS 10.40 is amended by adding a new section to read:

16 Sec. 10.40.105. ANNUAL REPORT. A corporation formed under this  
17 chapter shall file an annual report with the commissioner of commerce  
18 setting out the real and personal property assets of the corporation.
