6 For an Act entitled: "An Act providing for the issuance of general obliga-
7 tion bonds in the amount of \$14,400,000 for the purpose
8 of paying the cost of constructing health and social
9 services facilities; and providing for an effective
10 date."

11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

12 * Section 1. For the purpose of paying the cost of constructing health
13 and social services facilities, general obligation bonds of the state in the
14 principal amount of not more than \$14,400,000 shall be issued and sold. The
15 full faith, credit and resources of the state are pledged to the payment of
16 the principal of and interest and redemption premium, if any, on these bonds.
17 These bonds shall be issued under the provisions of AS 37.15 as those pro-
18 visions read at the time of issuance.

19 * Sec. 2. If the issuance of these bonds is authorized by the qualified
20 voters of the state, a special fund of the state to be known as the "Health
21 and Social Services Facility Fund" shall be established, to which shall be
22 credited the proceeds of the sale of the bonds described in sec. 1 of this
23 Act except for the accrued interest and premiums. There is appropriated from
24 the "Health and Social Services Facility Fund" to the Department of Health
25 and Social Services the amount of \$14,400,000. The proceeds of these bonds
26 shall be allocated in accordance with the following projects and estimates:

* Sec. 3. If the issuance of these bonds is authorized by the qualified voters of the state, the amount of \$50,000 or as much of that amount as is found necessary is appropriated from the general fund of the state to the state bond committee to carry out the provisions of this Act and to pay expenses incident to the sale and issuance of the bonds authorized in this Act. The amounts expended from the appropriation authorized by this section shall be reimbursed to the general fund from the proceeds of the sale of the bonds authorized by this Act.

* Sec. 4. The question whether the bonds authorized in this Act are to be issued shall be submitted to the qualified voters of the state at the next general election and shall read substantially as follows:
