6 For an Act entitled: "An Act creating the Redoubt Bay State Game Refuge."

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

8 \* Section 1. AS 16.20 is amended by adding a new section to read:

9 Sec. 16.20.034. REDOUBT BAY STATE GAME REFUGE. (a) The follow-  
10 ing state-owned land, including tide and submerged land, and all land,  
11 including tide and submerged land, acquired in the future by the state  
12 lying within the parcels described in this subsection is established as  
13 the Redoubt Bay State Game Refuge:

14 (1) Township 5 North, Range 16 West, Seward Meridian  
15 Sections 4 - 9, 18

16 (2) Township 5 North, Range 17 West, Seward Meridian  
17 Sections 1 - 34

18 (3) Township 6 North, Range 15 West, Seward Meridian  
19 Sections 4 - 9, 18

20 (4) Township 6 North, Range 16 West, Seward Meridian  
21 Sections 1 - 24, 26 - 34

22 (5) Township 6 North, Range 17 West, Seward Meridian  
23 Sections 1 - 18, 20 - 24, 25 - 29, 32 - 36

24 (6) Township 7 North, Range 14 West, Seward Meridian  
25 Sections S1/2 5, 6 - 8, 18

26 (7) Township 7 North, Range 15 West, Seward Meridian

9 (13) Township 9 North, Range 16 West, Seward Meridian  
10 Sections 19 - 21, 28 - 33

11 (b) The state may not acquire by eminent domain privately owned  
12 land within land specified in (a) of this section for inclusion in the  
13 Redoubt Bay State Game Refuge. The Department of Natural Resources  
14 may adopt, in accordance with the Administrative Procedure Act (AS 44.-  
15 62), zoning regulations governing privately owned land within the  
16 Redoubt Bay State Game Refuge.

17 (c) Egress and ingress to and from private property within the  
18 parcels described in (a) of this section shall be allowed through  
19 access corridors established through agreement between the Department  
20 of Natural Resources, the Department of Fish and Game, and the private  
21 property owners involved.
